## National Wildlife Refuge Hunting and Fishing



### Hunting Regulations Table

Hunting is in accordance with State regulations. In addition, Refuge-specific regulations must be followed and are listed in the table below.

Activity	Season Dates	Other Regulations
<b>Big Game - Mule deer, white-tailed deer</b>	State regulations apply	<p>Legal weapons include archery equipment, muzzleloaders, and centerfire rifles.</p> <p>Archery hunters must possess a valid State archery deer hunting license.</p> <p>Centerfire rifle hunters must possess a valid State youth/mentor/apprentice license. No other rifle licenses are allowed.</p> <p>Muzzleloader hunters must possess a valid State muzzleloader deer hunting license specific to Lacreek NWR.</p> <p>The Refuge is closed to archery and youth/mentor/apprentice deer hunting during Lacreek NWR muzzleloader seasons. Refer to the South Dakota Game, Fish and Parks Refuge Deer Application form for muzzleloader season dates.</p> <p>Portable tree stands and free-standing platforms may be left on the Refuge from August 25 through February 15. All other personal property must be removed at the end of each day.</p>
<b>Upland Game - Cottontail rabbit, pheasant, prairie chicken, sharp-tailed grouse</b>	State regulations apply	<p>The Refuge is closed to the "Resident Only" pheasant season as described by the State of South Dakota.</p> <p>Cottontail rabbits can be taken with shotgun, archery equipment, and rimfire rifles.</p>
<b>Migratory Birds - American crow, common snipe, coot, dark geese, duck, light geese, mourning dove, sandhill crane</b>	State regulations apply	<p>Light geese can be taken during the State-defined fall/winter season, but are closed during the spring Conservation Order.</p> <p>American crow can be taken with shotgun or archery equipment, sunrise to sunset, during the State-defined fall season (daylight hours only, no rifles, no spring season).</p>
<b>Predators - Bobcat, coyote, mountain lion, red fox</b>	January 1 – February 15	<p>May hunt one-half hour before sunrise to one-half hour after sunset.</p> <p>The use of dogs for predator hunting or locating is prohibited.</p>

The Blue Goose is the symbol of the National Wildlife Refuge System, a network of lands and waters managed for the benefit of wildlife and people.



### Welcome

Welcome to Lacreek National Wildlife Refuge (NWR). The Refuge was established by President Franklin D. Roosevelt in 1935 as a refuge and breeding ground for migratory birds and other wildlife.

### General Information

Refuge headquarters is located 12 miles southeast of Martin, South Dakota and is open from 7:00 am to 3:30 pm, Monday through Friday, except Federal holidays.

Motor vehicles are allowed only on designated roads and in hunter parking areas.

Motorized boats may be used for hunting and game retrieval on the Little White River Recreation Area. Manual-powered boats may be used for hunting and game retrieval on all waters within open hunt areas. Boats with electric motors may be used on Pool 10.

If you open a gate to enter a hunting area, immediately close it behind you.

Camping is allowed in the Little White River Recreation Area. All other Refuge lands are closed to overnight use.

### Prohibited Activities

- Accessing the hunting area from anywhere other than a designated hunter parking area, adjacent public lands, or adjacent private lands enrolled in public access programs.
- Entering the Refuge to retrieve game that was shot from private land or road rights-of-way.
- Shooting over Refuge property from adjacent road rights-of-way or private land.

- Loaded firearms on any Refuge roadway.
- Discharging a firearm over or across any Refuge roadway and within 33-feet from the centerline of any Refuge roadway.
- Hunting from or with the aid of vehicles except for hunters possessing a Disabled Hunter Permit and a special use permit issued by the Refuge Manager.
- Target shooting.
- Possession of toxic shot while hunting.
- Use of electronic or photographic trail monitoring cameras or other devices.
- Collecting or removing artifacts, historic items, shed antlers, and other natural objects.
- Dog training.
- Using horses to hunt or retrieve game.
- Possession of alcohol while hunting.
- Open fires except in designated sites at Little White River Recreation Area.

### Firearms

Persons possessing, transporting, or carrying firearms on National Wildlife Refuge System lands must comply with all provisions of State and local law. Persons may only use (discharge) firearms in accordance with refuge regulations (50 CFR 27.42 and specific refuge regulations in 50 CFR Part 32.)

### Accessibility

### Hunting and Fishing Regulations

Hunting and fishing are permitted in accordance with Federal regulations governing public use on National Wildlife Refuges as set forth in Title 50 of the Code of Federal Regulations.

Hunting and fishing are allowed on the Refuge in accordance with State regulations and the Refuge-specific regulations in this brochure.

Hunters and anglers may hunt or fish only in areas open to hunting or fishing as shown on the map.

### Hunting

Hunter access is allowed 2 hours before sunrise until 2 hours after sunset.

Hunters must enter and exit hunting areas from a designated hunter parking area, adjacent public land, or adjacent private land that is enrolled in a public access program.

Coyotes and all furbearers or their parts, if left in the field, must be left at least 50 yards away from any road, trail, or building. Otherwise, hunters must remove them from the Refuge.

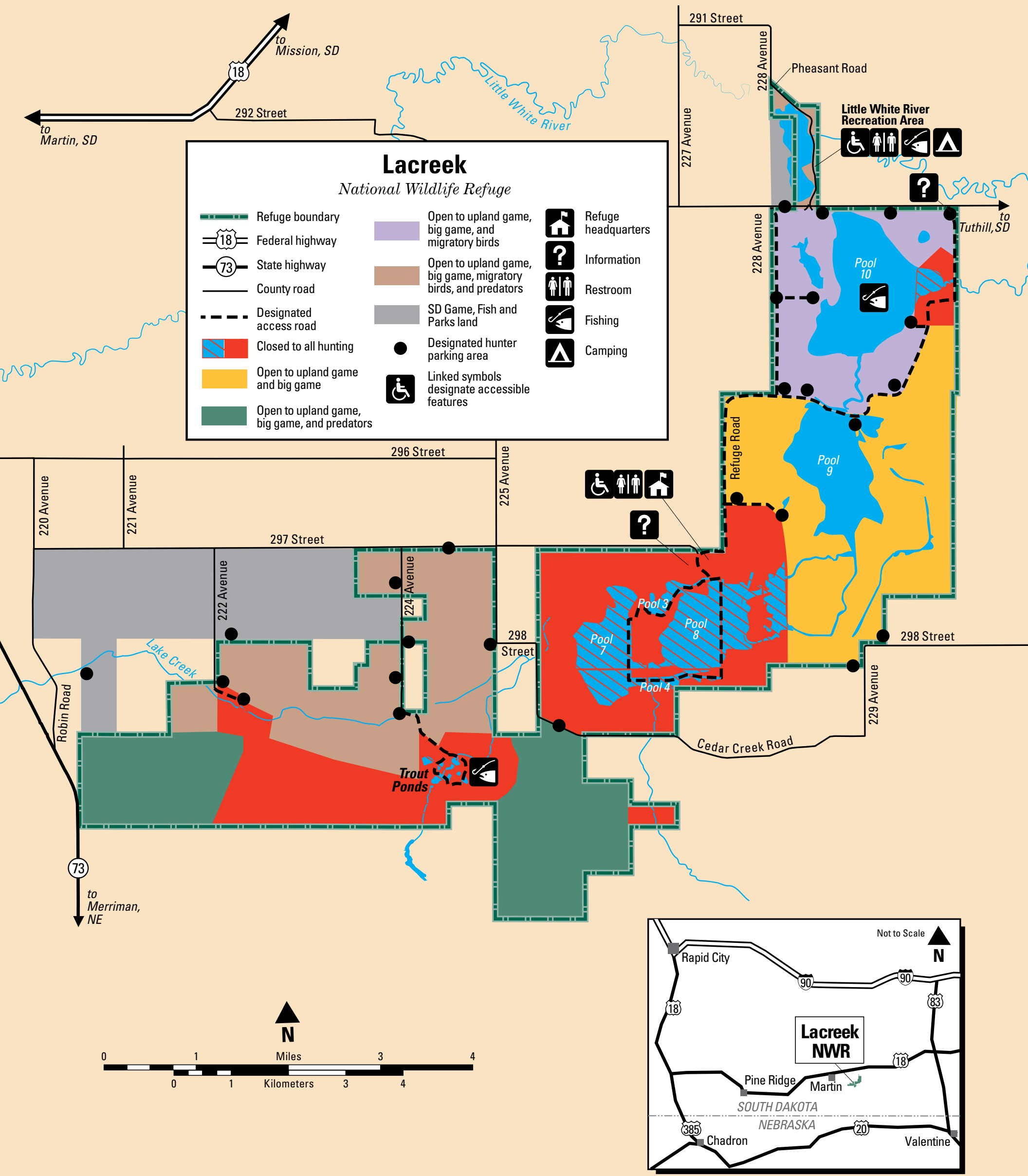

**Fishing**

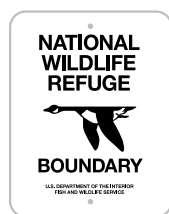
The Refuge is open to fishing at the Trout Ponds and Pools 3, 4, 7, and 10 from one-half hour before sunrise until one-half hour after sunset. Little White River Recreation Area is open to fishing 24 hours per day.

The use or possession of live minnows or bait fish is prohibited on the Refuge except at Little White River Recreation Area.

Snapping turtles may be harvested in areas open to fishing and within 300 feet of any road open to public travel.

**Signs**

The wording of the sign applies to the area located behind the sign, except for parking signs. Please respect the following signs.



Refuge Boundary – Authorized activities only. All Refuge areas are considered closed to public entry unless opened by public notice, regulation, brochure, or by special permit. Entry permitted in accordance with Refuge regulations.



Shooting over Refuge property from adjacent road rights-of-way or private land is prohibited. The entire Refuge is closed to the retrieval of game shot from private land or road rights-of-way.



Hunting, weapons, and game retrieval prohibited.



Hunters must enter and exit hunting areas from a designated hunter parking area, adjacent public land, or adjacent private land that is enrolled in a public access program.
