Lake Nettie National Wildlife Refuge (NWR) is one of over 560 refuges in the National Wildlife Refuge System – a network of lands set aside specifically for wildlife. Managed by the U.S. Fish and Wildlife Service, the Refuge System is a living heritage, preserving wildlife and habitat for people today and for generations to come.

Lake Nettie NWR is located 10 miles east and 6 miles north of Coleharbor, ND, and is managed as part of the Audubon NWR Complex. The Refuge consists of 3,055 acres of diverse wetlands, native prairie, and planted grasslands. These habitats are managed to provide food and shelter for migratory birds, as well as resident wildlife.

Deer Hunting

*Bow, Gun, and
Muzzleloader*

Hunting is permitted for deer as described below and as illustrated on the map on the reverse side of this leaflet. Hunting of all other wildlife species is prohibited.



All Federal and State hunting regulations apply.

The Refuge is divided into areas which are designated as open or closed to deer hunting as shown on the map. Areas closed to hunting are posted with ‘No Hunting Zone’ signs.

Hunters may use bow, gun, or muzzleloader to hunt for deer in Refuge areas open to hunting. Hunters must comply with State regulations and seasons, including the youth deer hunting season.

Hunters must park at the Refuge boundary and walk into the Refuge to access areas open to hunting.

Hunters may walk in to retrieve a harvested deer that falls in an area marked with no hunting signs. Retrieval is limited to direct travel to and from the deer, and no firearms may be carried while retrieving deer in these areas.

Deer hunters may not drive on Refuge roads while hunting or retrieving deer.

Hunters may use portable tree stands that meet State regulations. Tree stands and ground blinds may not be left up overnight.

Persons possessing, transporting, or carrying firearms on National Wildlife Refuge System lands must comply with all provisions of State and local law. Persons may only use (discharge) firearms in accordance with refuge regulations (50 CFR 27.42 and specific refuge regulations in 50 CFR Part 32).


Prohibited Activities

Please note that the following activities are prohibited on the Refuge:

- Using or possessing alcoholic beverages while hunting.
- Using bait to lure animals.
- Using horses to hunt or to retrieve game.
- Removing natural objects and artifacts.
- Camping and open fires.
- Littering.

Accessibility Information




Lake Nettie
