

*Deer-Firearms  
Permits*

Rice Lake NWR is state designated "Special Permit" Area 901 for either sex permits. **Area 901 permit holders may hunt in Unit A only. See map for details.** Hunters apply to the MN Department of Natural Resources for a Special Area Permit according to regulations and procedures. Details on the firearms hunt, dates and application procedures are outlined in the annual Minnesota Hunting and Trapping Regulations booklet for the "either sex" permit. Contact the refuge office for application procedures for the disabled access deer hunt.

*Deer  
Registration*

Deer taken by archery may be registered at any authorized Registration Station. Also, please notify the refuge office of any deer taken to aid in our management program.

*Hunting  
Stands*

Only portable stands not requiring the use of nails, screws, bolts or other metal objects to be driven into the tree to support a hunter may be used. Stands must not be left overnight.

*Alcohol*

The use or possession of alcoholic beverages while hunting on National Wildlife Refuges is prohibited. Have a safe hunt!

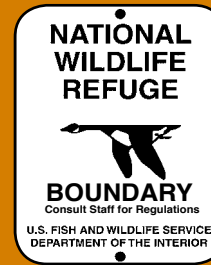

### **Refuge Signs - Know Their Meaning!**

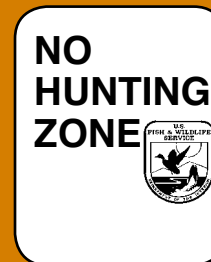
*Refuge Boundary*

*Seasons*

**Special Conditions**

Archery deer, small game and migratory bird (woodcock and snipe only) hunting is permitted in accordance with state seasons and dates in the units designated as open to public hunting. The Wildlife Drive and hiking trails are closed to hunting.

*Access*

Vehicle travel is limited to designated parking areas. Snowmobiles, ATVs, and other off-road vehicles are not permitted on the refuge.

*Camping*

Overnight camping and open fires are prohibited.

*Littering*

Littering is prohibited. Pack your trash (including shotgun shell casings) out with you so that the area will remain clean, natural, and enjoyable.

*Non-toxic Shot*

Shotgun hunters must use non-toxic shot. The possession of lead shot is prohibited while in the field.

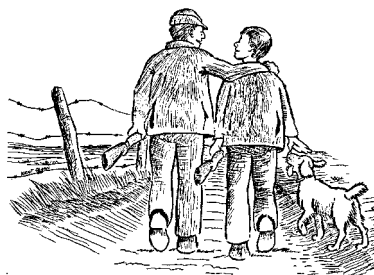
*Other Regulations*

The refuge is CLOSED to duck, goose and other migratory bird hunting. The refuge is OPEN to woodcock and snipe only.

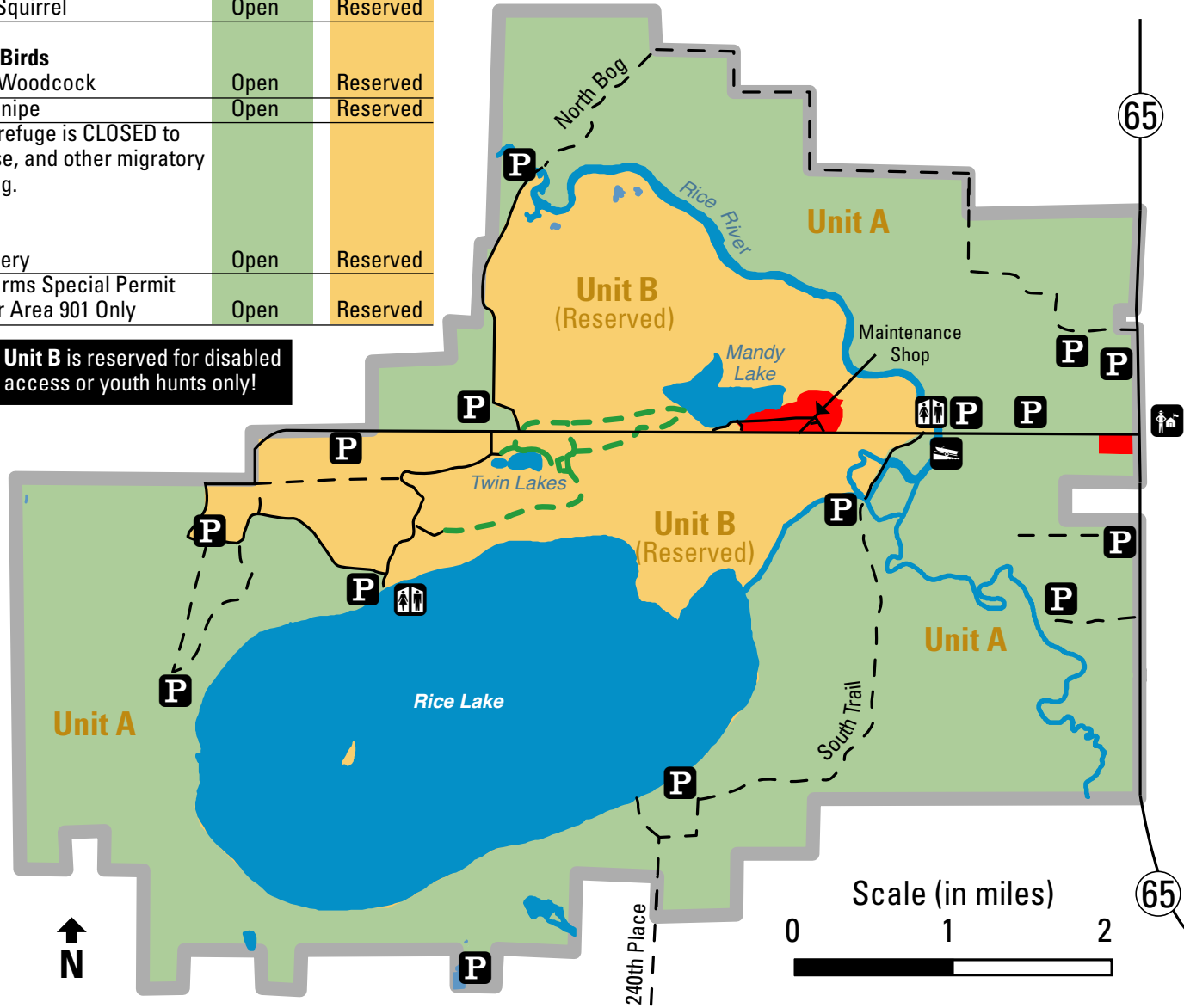
