LAW ENFORCEMENT POSITION PAPER

On January 15th, Director James Ridenour signed a document entitled "National Park Service Organizational Position Paper on Law Enforcement in the Protection Ranger Work Force." That document is attached to this issue of Clear Text as a WordPerfect 5.1 file entitled LE-POS.

The paper defines the mission and goals of the Service's law enforcement program in contemporary terms, and emphasizes the primacy of prevention and resource education. It reconfirms the agency's fundamental mission of resource conservation and specifies that NPS law enforcement is an essential tool for accomplishing the objectives of park resource and visitor protection. And it articulates the Service's support for park staff members who are assigned to law enforcement duties.

Over coming months, we will collectively review, resolve and plan the most appropriate methods for implementing the principles articulated in this document. All levels of management will have ample opportunity to address concerns and shape decisions regarding the direction that park law enforcement programs will take. This position paper provides us with an impetus for resolving the operational issues necessary for the implementation of a modern resource and visitor protection program.

We will keep you abreast of further developments.

CHIEF RANGERS' DIRECTORY

The final draft of the newly revised NPS chief rangers' directory is also attached to this issue in a file entitled CR-LIST. It must be downloaded to a disk, then printed locally. The directory is in WordPerfect 5.1; although all necessary commands are buried in it, you should nonetheless be aware that it has been composed in Courier 12 cpi for a Laserjet III printer, that the margins are set at 8 and 18, and that it has its own headers and footers. You may have to work with it a bit to get it to come out on any other kind of printer. If you just can't get it to print, send us a cc:Mail message with your postal address and we'll mail you a copy.

Please keep in mind that this is a final draft, not the end product. If you find any errors on it, send in your corrections via cc:Mail. We'll update the directory and retransmit it in final form later this spring.

GUIDELINES

Revisions to several guidelines are underway and in various states of completion. Here's a quick summary:

* NPS-58 - The rewrite of NPS-58, the structural fire guideline, has begun. Efforts will be made to enhance the existing version and make it more responsive to the needs of field areas. The effort is being directed by Jim Farrel, the structural fire program manager, with assistance from staff in the Branch of Loss Control Management and

personnel who were involved in preparation of the original guideline. Because of the complexity of the issues and the desire to build-in adequate review processes, it appears likely that the project will take about a year and a half to complete. Many field people will be contacted for input on revisions to various sections of the guideline as the work progresses.

- * NPS-43 - Revisions to the Service's uniform guideline were completed in December and it is now going through its final internal clearance prior to release. The rewrite began in January, 1991, when a work group met in WASO and completely revised the guideline, which had not been updated since its initial release in 1984. Last January, the Servicewide uniform committee worked those revisions into a second draft which went out for field review in the spring. Almost all field comments were incorporated into the final version.
- * NPS-57 - The health and fitness guideline is currently being printed. About 6,000 copies will be run and distributed as widely as possible.
- * NPS-9 - The guideline is currently on hold because of revisions being made to the Service's law enforcement policies.

UNIFORM BOOTS

On February 5th, we began a month-long, Servicewide needs assessment to determine what type of hiking boot NPS employees feel we should have in the uniform program. In the past, we've approached this issue by asking for recommendations for specific boots, only to find that there's a decided lack of consensus on individual models. This time, we're going to instead attempt to first determine overall needs. Copies of the needs assessment form were sent to all park uniform program administrators via cc:Mail on February 5th. Employees who fill them out should send them to one of the below-listed people (preferably the one closest to you), all of whom are on the needs assessment work group:

They will review and collate the responses and forward them to Hugh Dougher, the group's chairperson. He will then meet with the Service's uniform coordinator and representatives from R&R Uniforms in mid-March to select a model for field testing. Please note that responses need to be submitted by February 24th.

An identical assessment is underway for a new field work boot - one which will also meet criteria for use in wildland firefighting. That evaluation form was also sent to your park uniform program administrator. It should be completed and sent to any of the members of that work group:

NOTES FROM THE PARKS

Grand Canyon

A ceremony was recently held at Grand Canyon School for 7th and 8th grade students who graduated from the 80-hour GREAT (Gang Resistance Education and Training) program. The course was taught and coordinated by ranger Joan Blais, who is also a DARE officer for the park community. During last summer, she worked with and was trained by the Phoenix police department's gang detail, and is the first NPS ranger to become a GREAT instructor. She's also been asked to serve on the national GREAT training team. GREAT is designed to combat and prevent youth gang involvement and is patterned after the DARE program. An increasing number of youths are bringing gang activity and problems from metro areas to the Grand Canyon and nearby rural areas. The course, which was created by ATF and Phoenix PD, targets junior high students and provides decision making skills and techniques to help juveniles avoid gang involvement.
