BULLFROG CAMPGROUND

FEES	YOU ARE REQUIRED TO PAY A FEE OF \$6.00 PER NIGHT. IF YOU HAVE A GOLDEN AGE OR GOLDEN ACCESS PASSPORT IN YOUR POSSESSION, THE FEE IS \$3.00. THE GOLDEN EAGLE PASSPORT DOES NOT APPLY TO CAMPING FEES. PLACE FEE ENVELOPE IN THE DROP BOX LOCATED AT THE ENTRANCE STATION. 36 CFR 2.23 (b)
CAMPING	CAMPING IS PERMITTED <u>ONLY</u> IN DESIGNATED LOCATIONS. PLEASE ATTACH THE FEE ENVELOPE STUB TO THE NUMBERED POST AT YOUR CHOSEN SITE.
DRIVING & PARKING	THE SPEED LIMIT IN THE CAMPGROUND IS 5 MPH AND THE TRAFFIC FLOW IN THE CAMPING LOOP IS ONE WAY. SPEED LIMITS AND TRAFFIC FLOW ARE ENFORCED FOR EVERYONE'S SAFETY. 36 CFR 4.21 (a)(1) PARK ALL VEHICLES WITHIN DESIGNATED SITE PARKING. 36 CFR 4.10 ALL VEHICLES (<u>INCLUDING MOUNTAIN BIKES</u>) MUST STAY ON ESTABLISHED ROADWAYS.
SITE CAPACITY	A MAXIMUM OF THREE (3) VEHICLES AND EIGHT (8) PERSONS PER SITE IS ALLOWED.
LENGTH OF STAY	CAMPING IS LIMITED TO 14 CONSECUTIVE DAYS, WITH A MAXIMUM 30 DAY STAY PER CALENDAR YEAR.
CHECK OUT TIME	CHECK OUT TIME IS 12 NOON. IF YOU PLAN TO BE AWAY FROM YOUR SITE DURING THE DAY, LEAVE SOME SIGN OF OCCUPANCY.
QUIET HOURS	QUIET HOURS ARE FROM 10 pm to 6 am. OPERATION OF GENERATORS OR OTHER AUDIO EQUIPMENT AND/OR UNREASONABLE NOISE IS NOT ALLOWED DURING THIS TIME. 36 CFR 2.34 36 CFR 2.12
TABLES & DELINEATION	TABLES AND CEMENT/ROCK BARRIERS ARE NOT TO BE MOVED! ONE TABLE PER SITE ALLOWED. BARRIERS ARE THERE TO STOP VEHICLES FROM DRIVING OFF PAVEMENT/GRAVEL. IF YOU HAVE MOVED ANY OF THESE, PLEASE MOVE THEM BACK IMMEDIATELY! 36 CFR 2.31
WASTEWATER & SEWAGE DISPOSAL	GREY WATER BUCKETS MUST BE USED ON ALL DRAIN HOSES. DISH WASHING MUST BE DONE AT THE FAUCETS LOCATED NEXT TO THE RESTROOM FOUNTAINS. THE SEWAGE DUMP IS LOCATED AT THE SOUTH END OF THE CAMPGROUND. POTABLE WATER IS AVAILABLE AT ALL RESTROOMS AND AT THE DUMP STATION. 36 CFR 2.14 (a)(1)
TRASH	ALL TRASH MUST BE PLACED IN THE DUMPSTERS. LEAVE YOUR CAMPSITE CLEAN AT ALL TIMES. THE RAVENS TEND TO GET INTO THINGS AND SPREAD THEM ALL OVER! THE NEXT CAMPER WILL APPRECIATE A CLEAN SITE.
NATURAL CONSERVATION	DAMAGING VEGETATION, CUTTING OR DEFACING TREES, DIGGING, TRENCHING OR LEVELING OF GROUNDS IS PROHIBITED.
IRRIGATION	CAMPGROUND IRRIGATION SYSTEM WILL BE TURNED ON EVERY MONDAY AND THURSDAY IN THE MORNING. BE SURE NOT TO PLACE TENTS OR GEAR NEXT TO SPRINKLERS. USE CAUTION AROUND SPRINKLERS AS THEY ARE EASILY BROKEN.
FIREARMS, ETC,	POSSESSION OF FIREARMS, EXPLOSIVES OR FIREWORKS IS PROHIBITED! 36 CFR 2.4 (a)(1) 36 CFR 2.4 (a)(3)(b) 36 CFR 2.38 (b)
PETS	PETS MUST BE KEPT ON A LEASH NO MORE THAN 6 FEET IN LENGTH AND UNDER CONTROL AT ALL TIMES. YOU ARE RESPONSIBLE FOR KEEPING YOUR PET QUIET. 36 CFR 2.15 (a)(2)
GROUND FIRES	GROUND FIRES ARE NOT PERMITTED. FIRES ARE ALLOWED IN GRATES PROVIDED OR IN CAMP STOVES.
