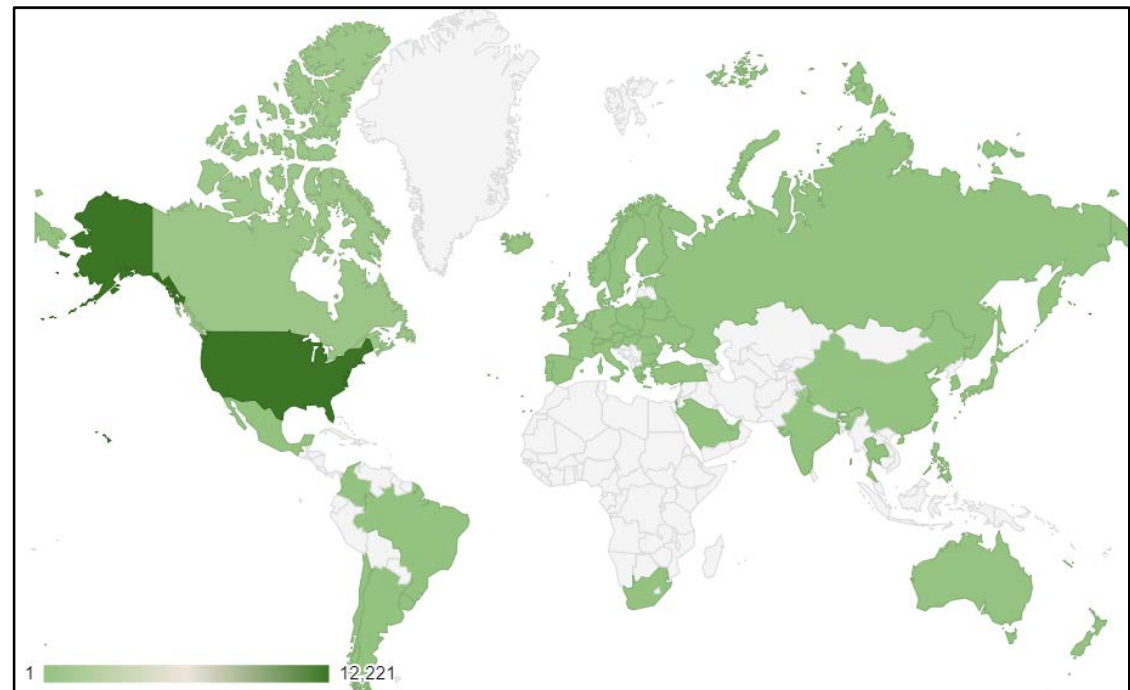

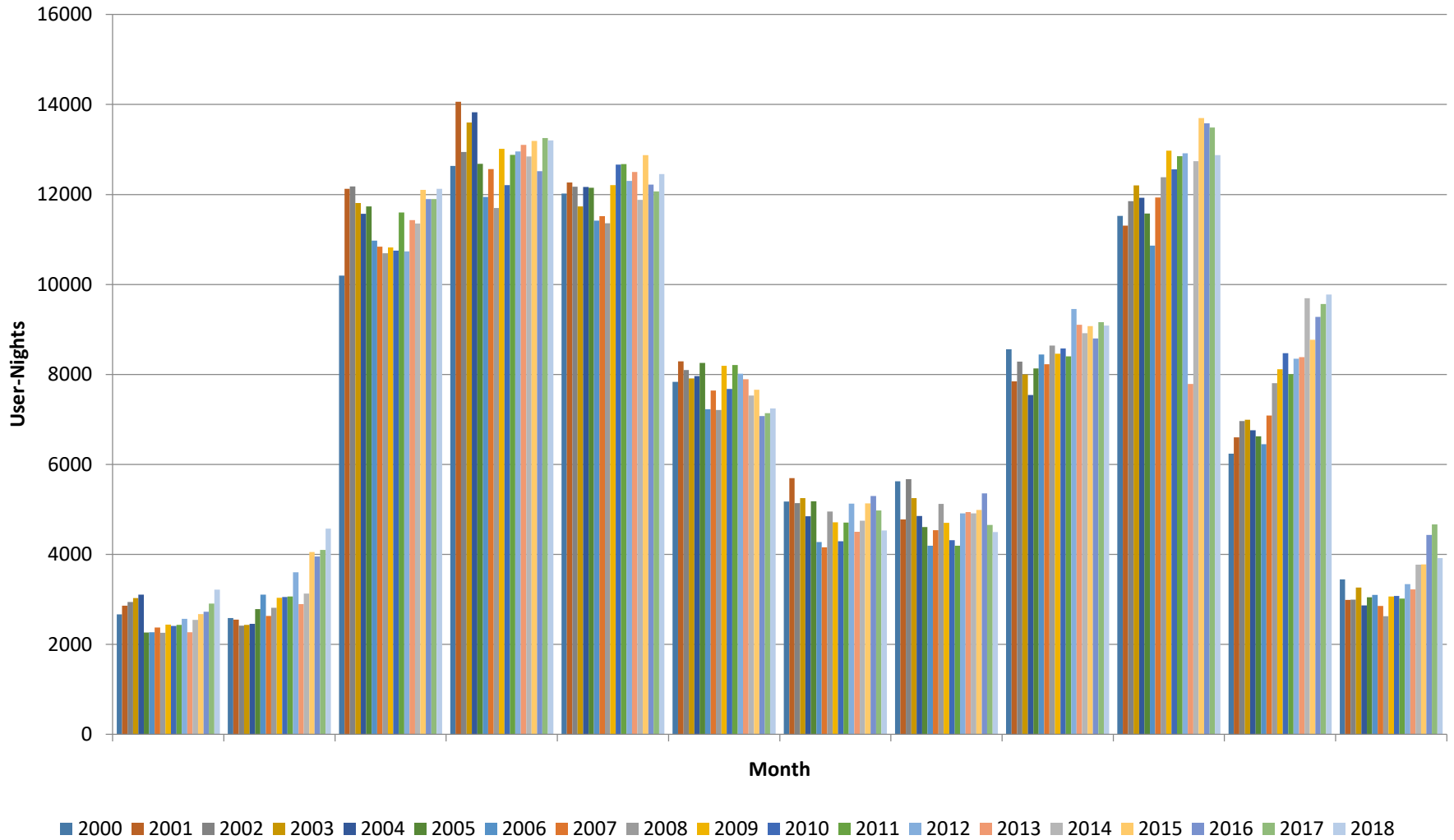

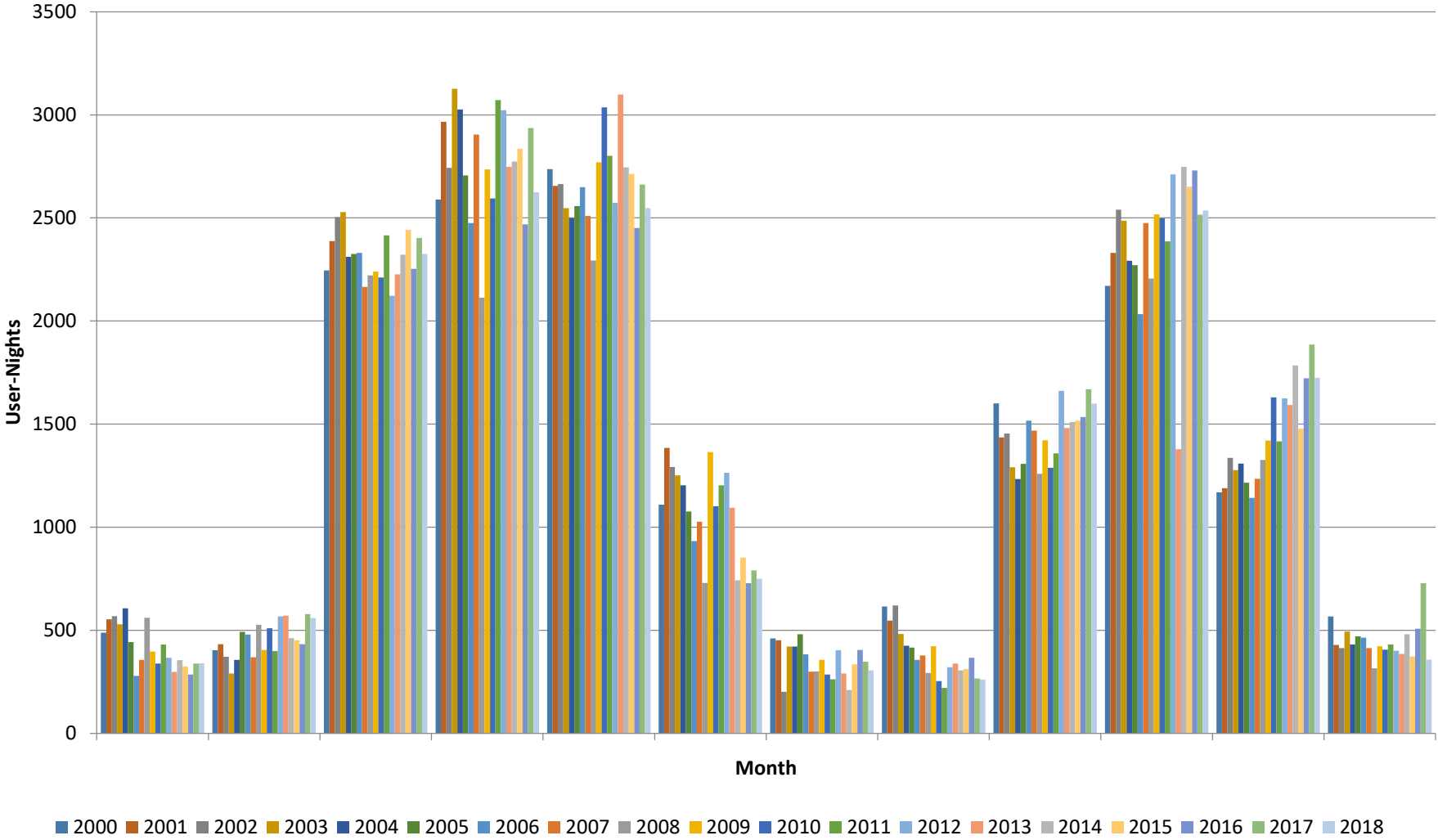


Backcountry Use Trends, 2000-2018 Corridor



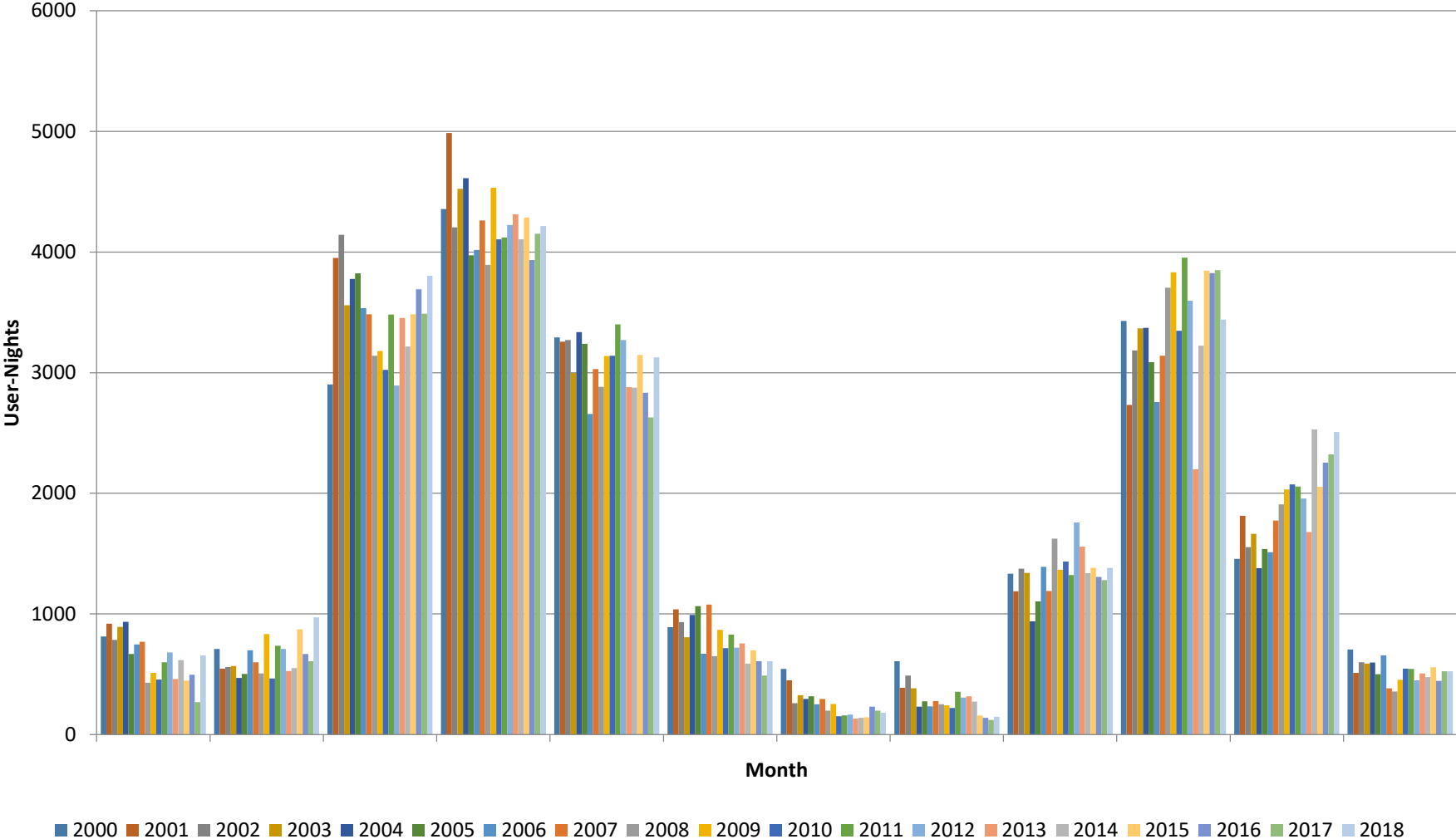

Threshold Use Areas



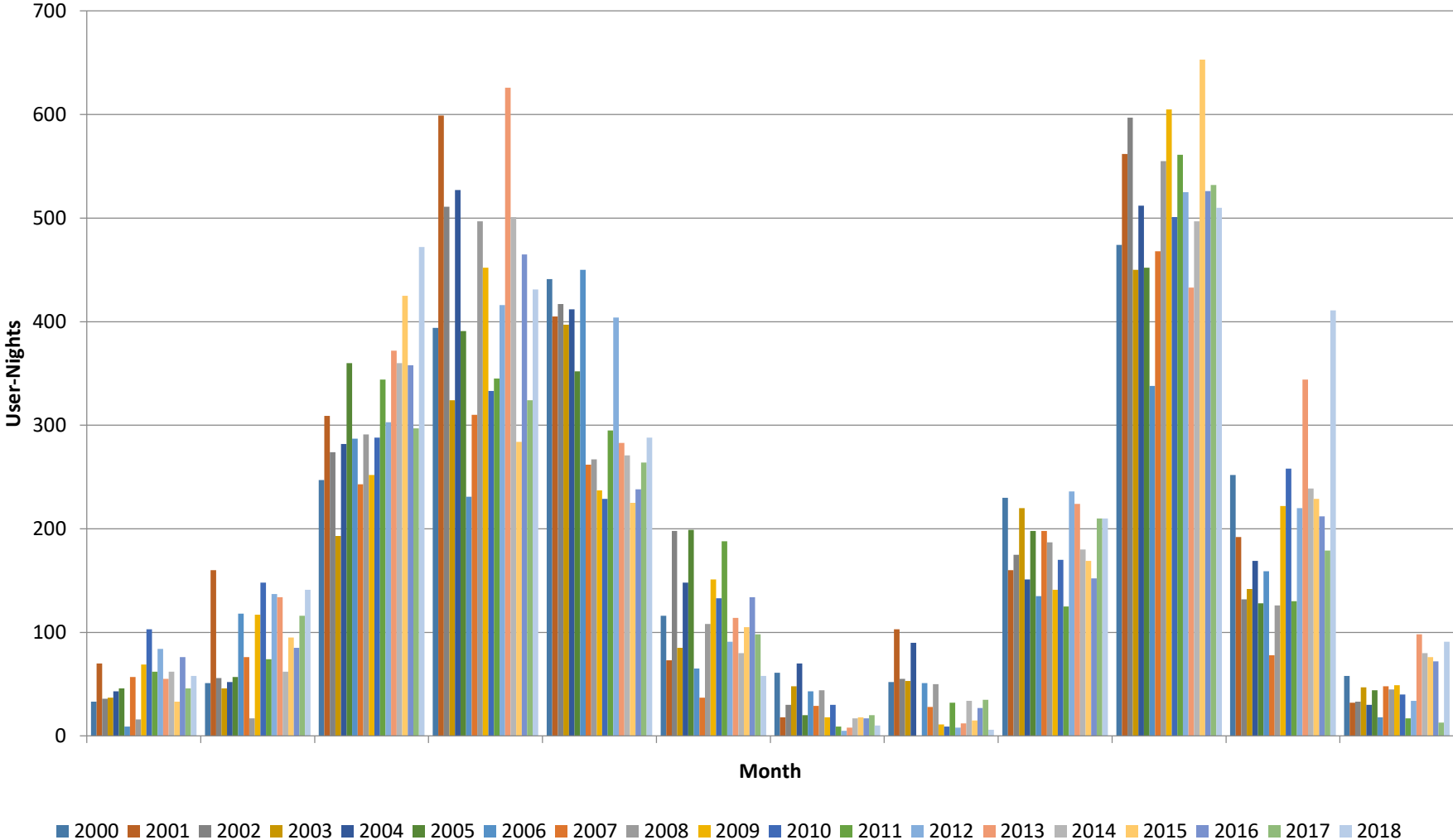

Primitive Use Areas

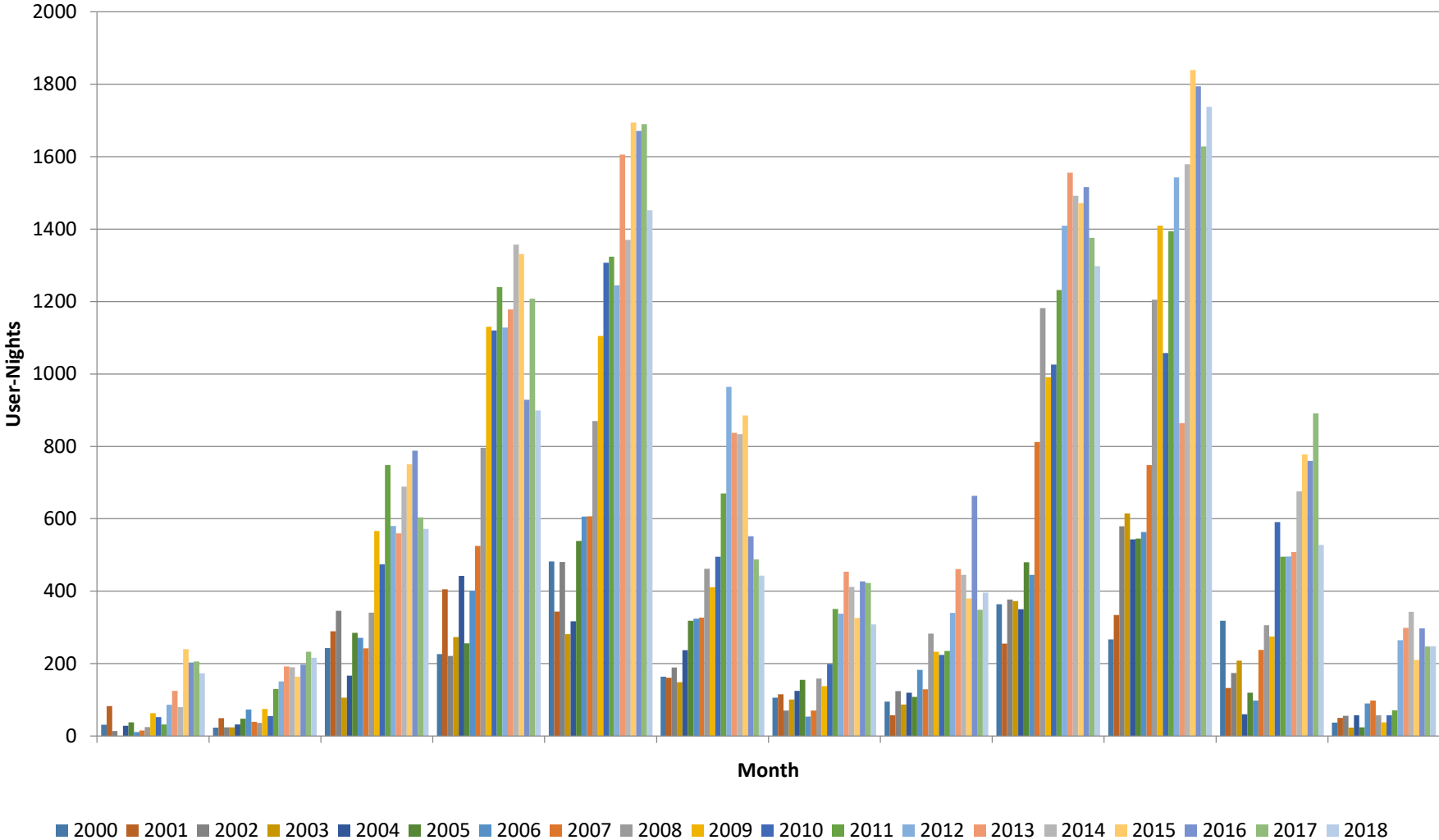

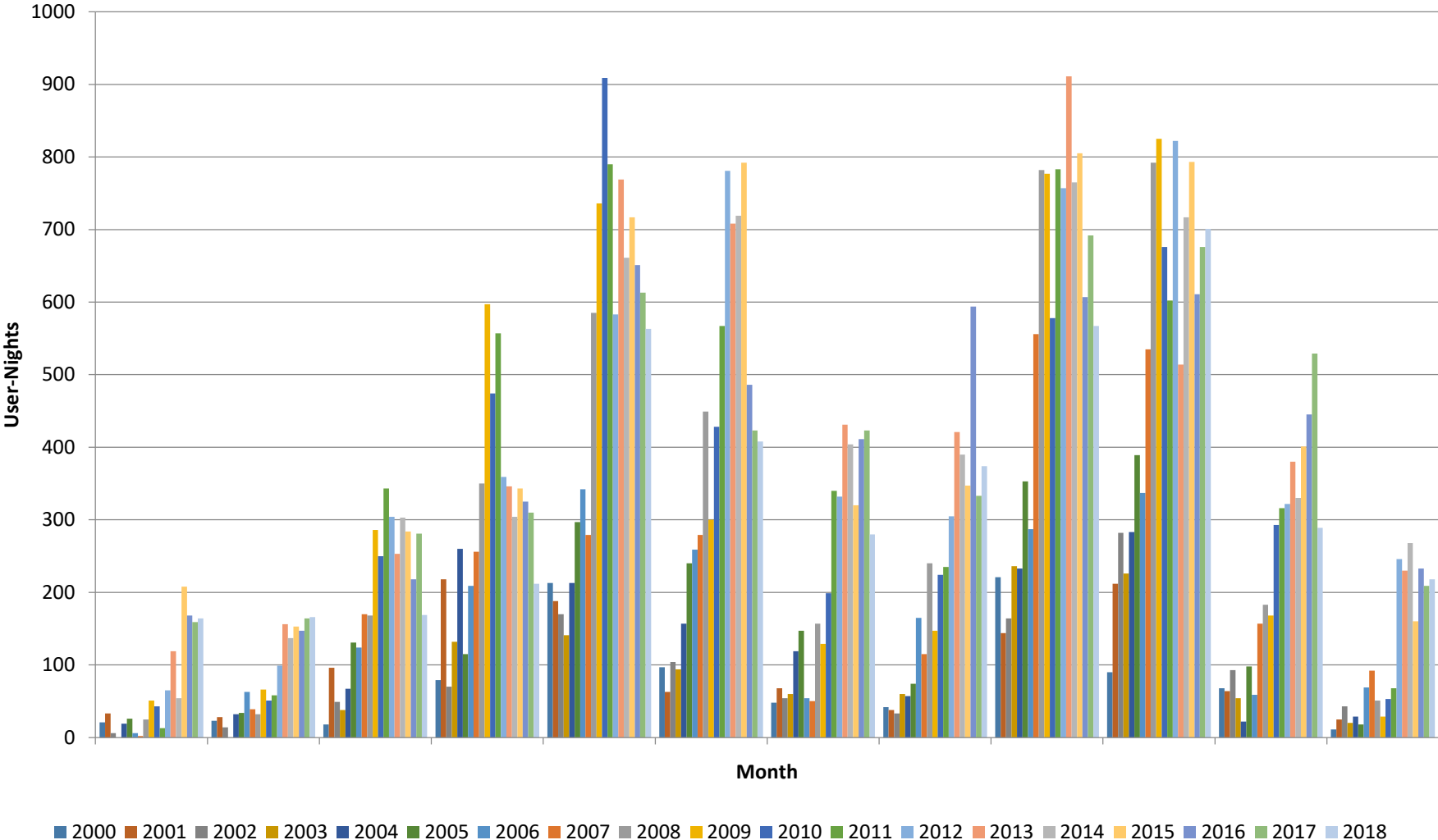

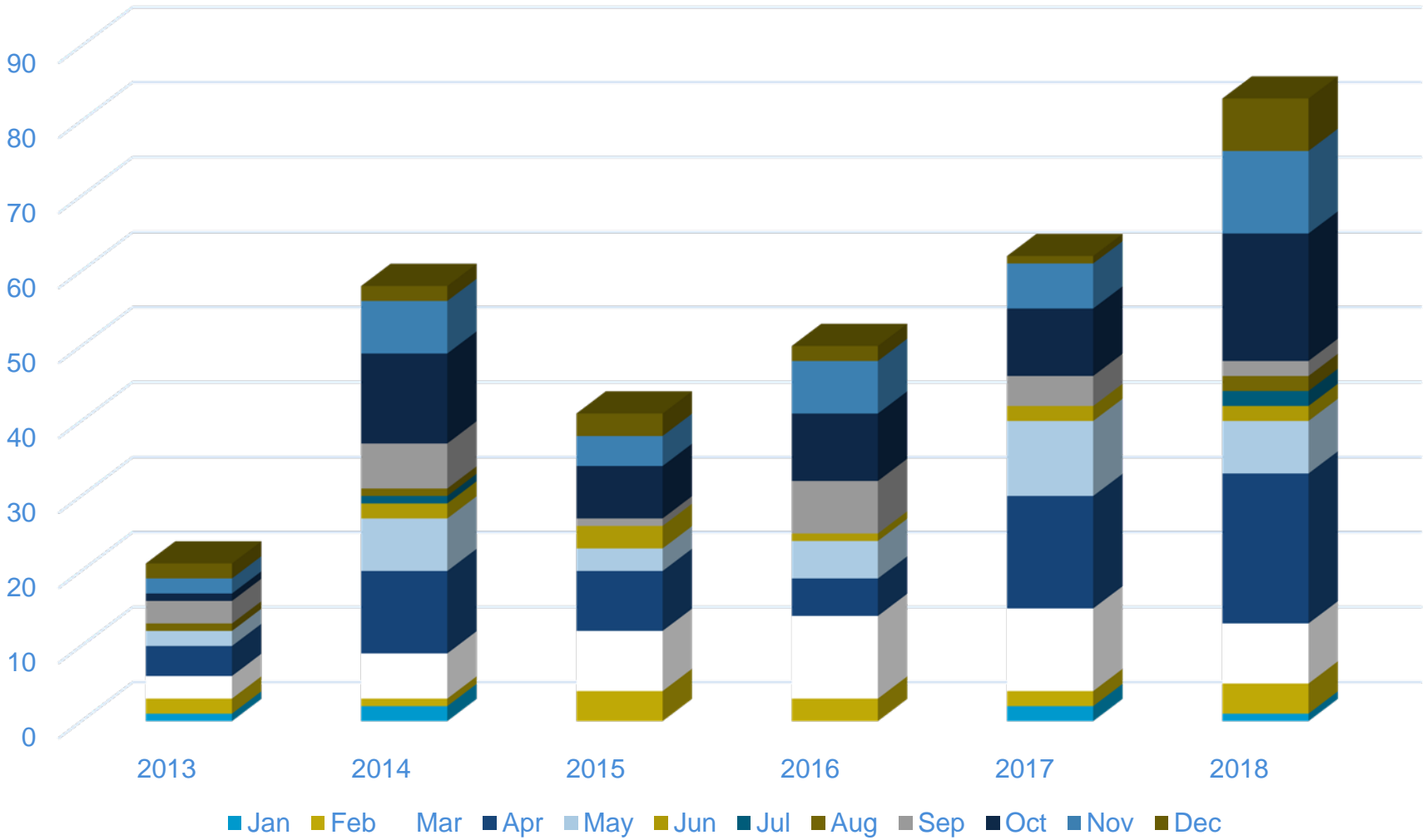
Backcountry Commercial Use, 2000-2018



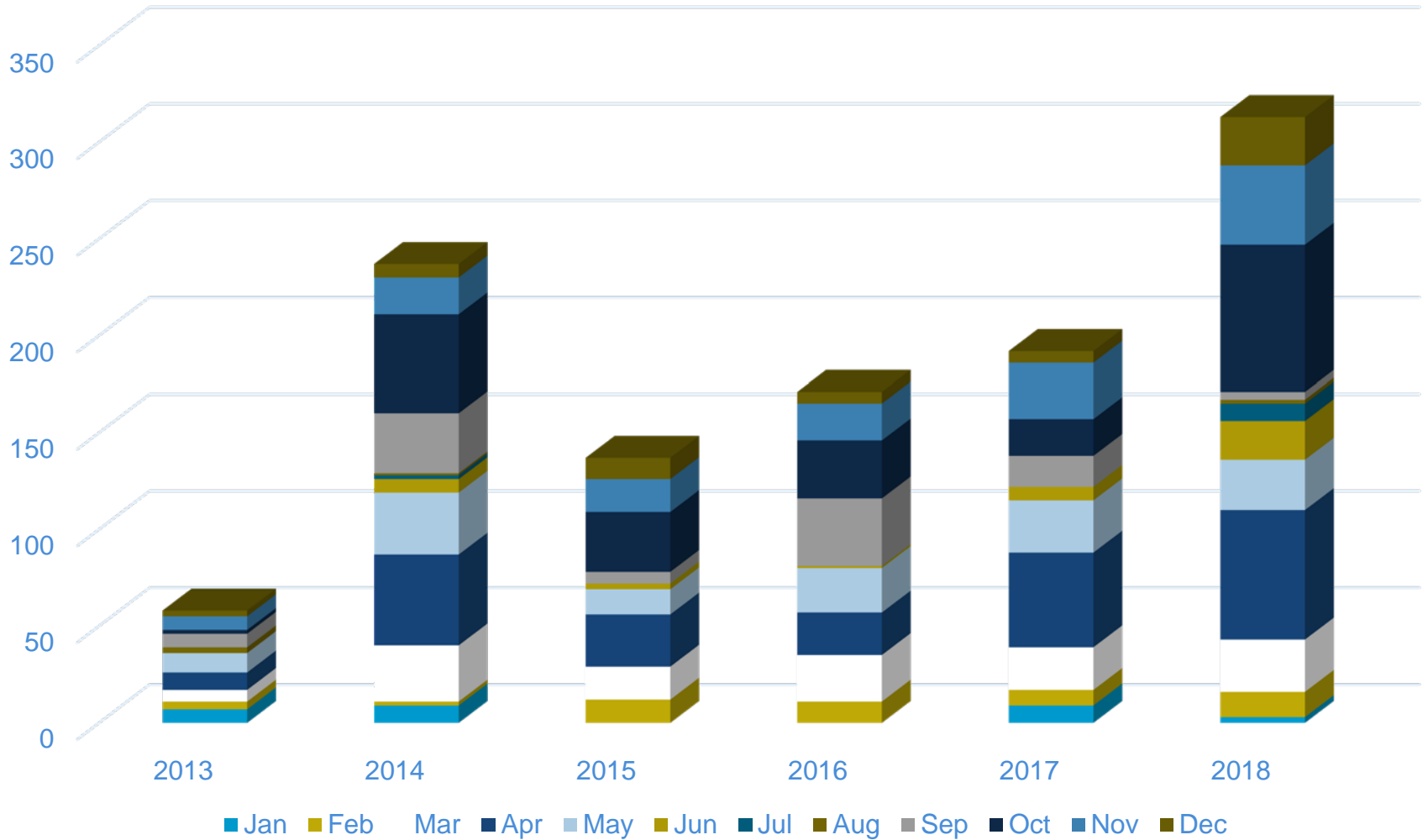
Backcountry Commercial Use in Corridor, 2000-2018



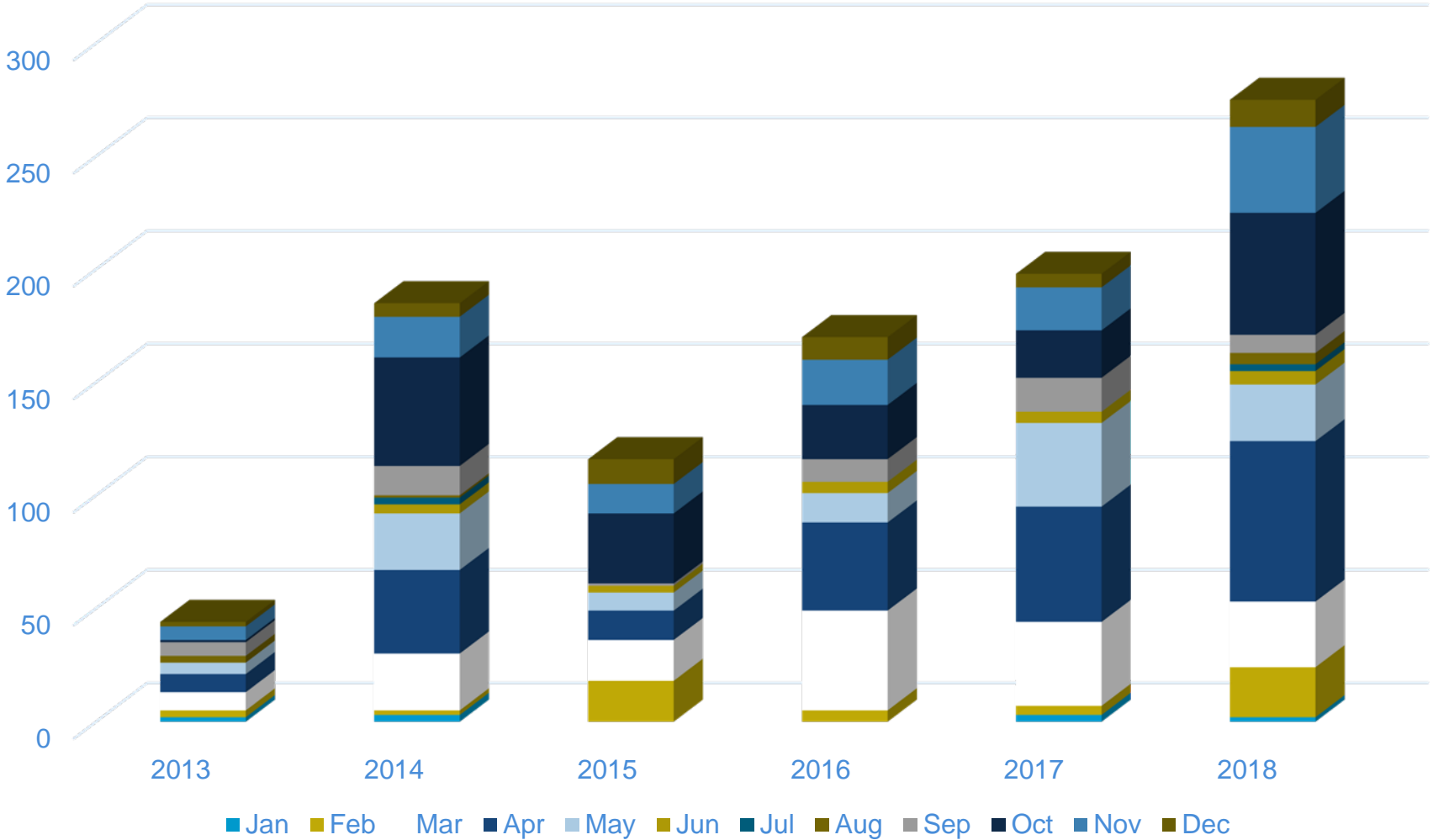

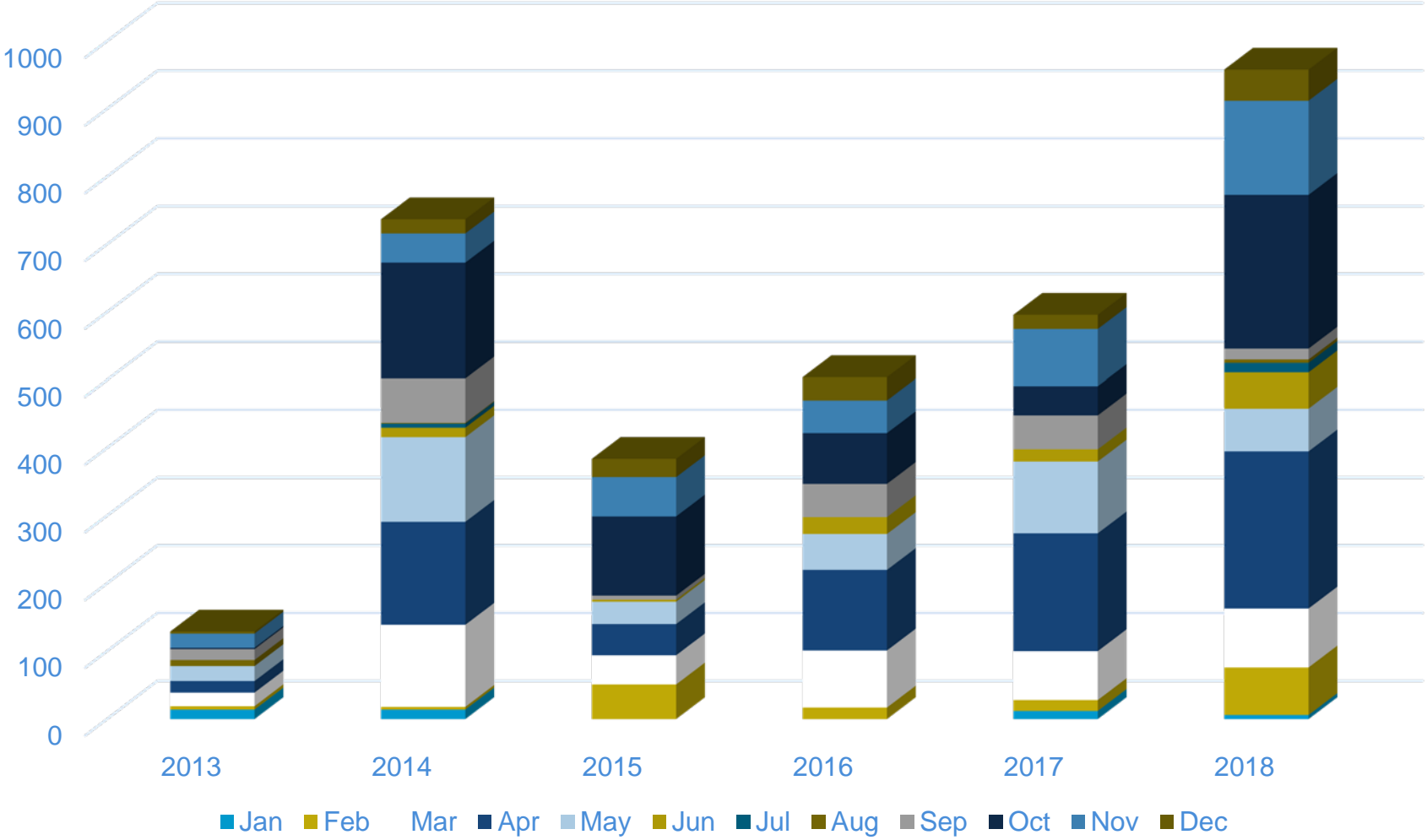

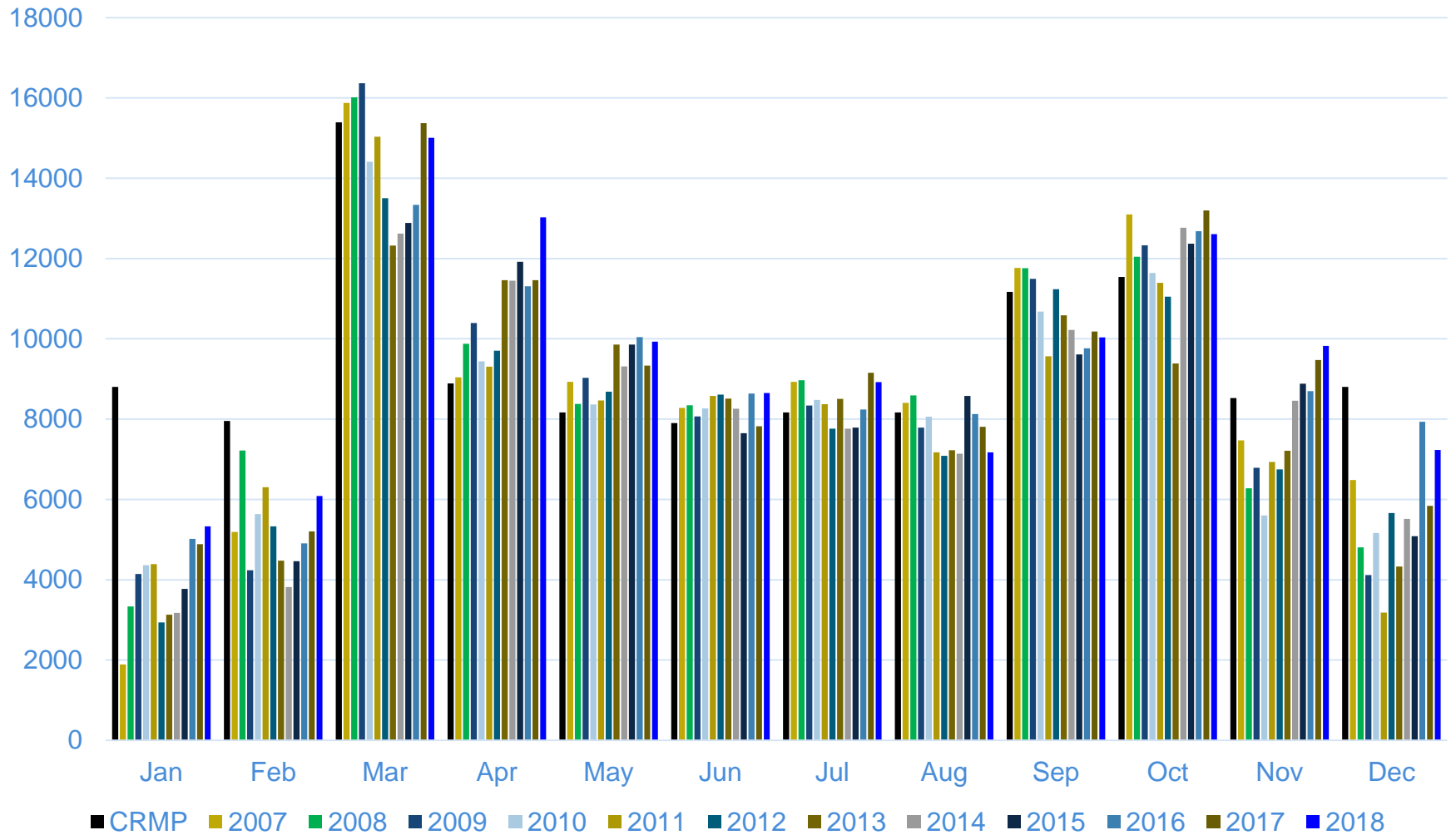
River – Lees Ferry to Diamond Creek Noncommercial - Trips



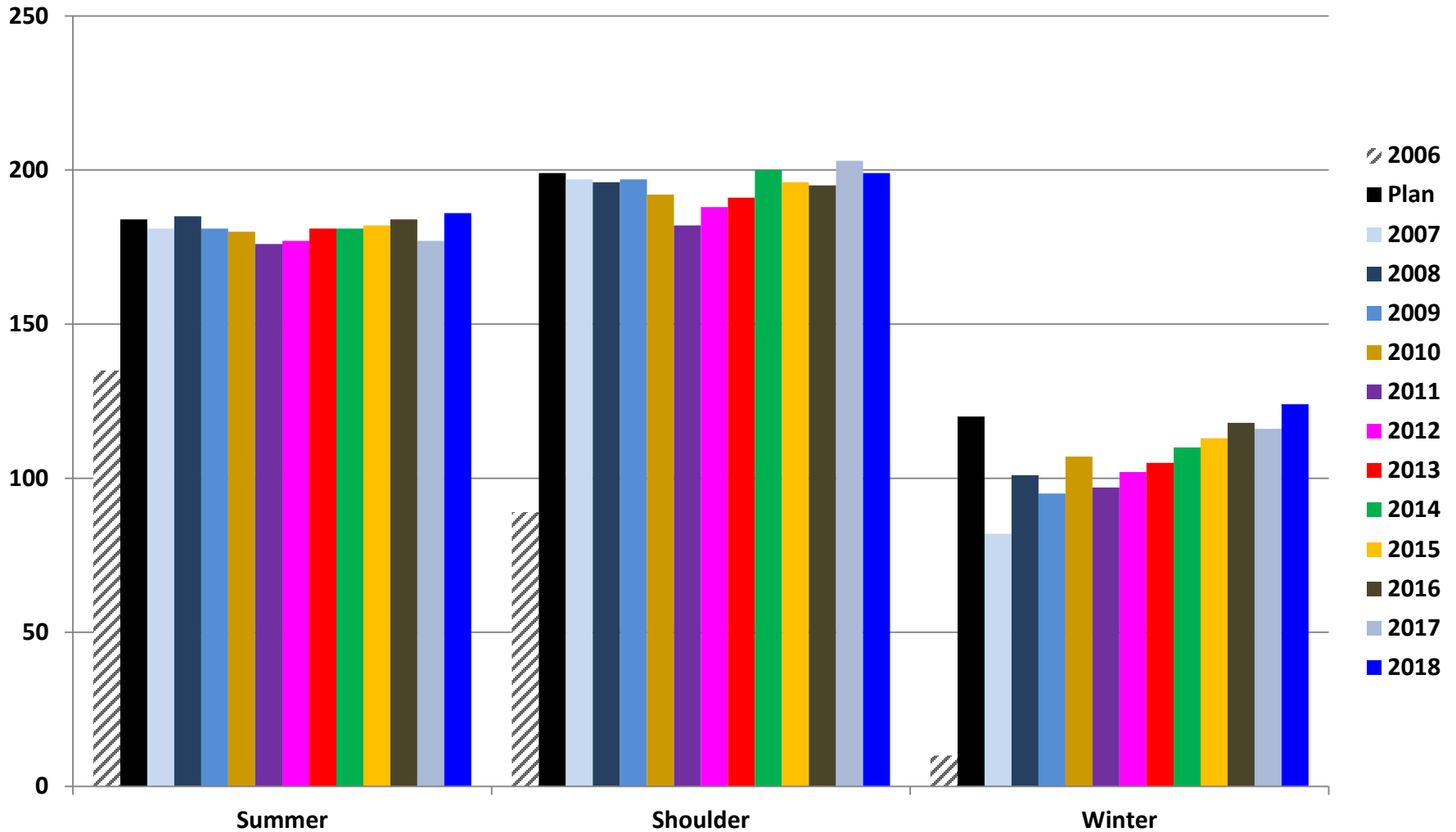
River – Lees Ferry to Diamond Creek Noncommercial - Passengers



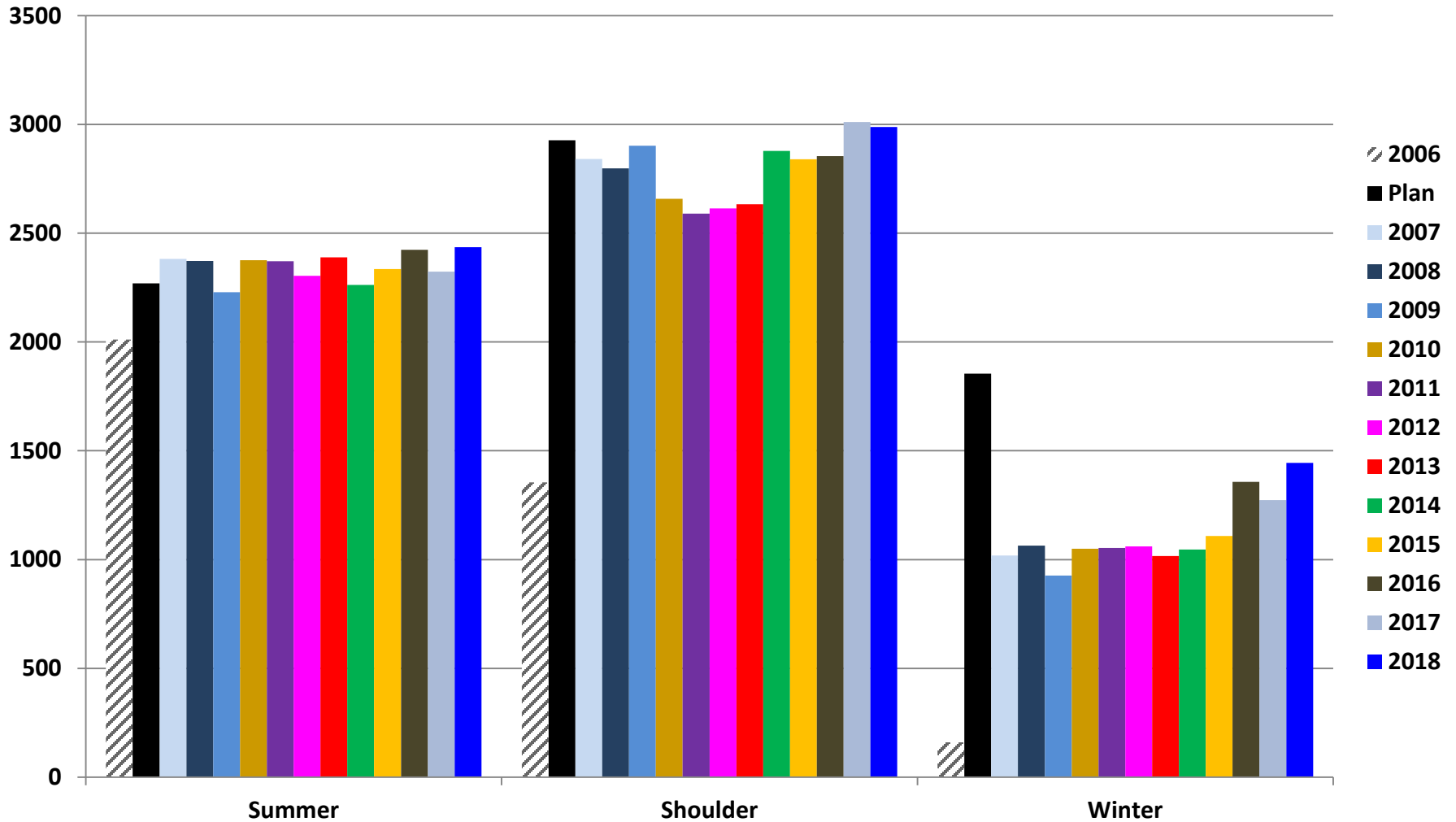

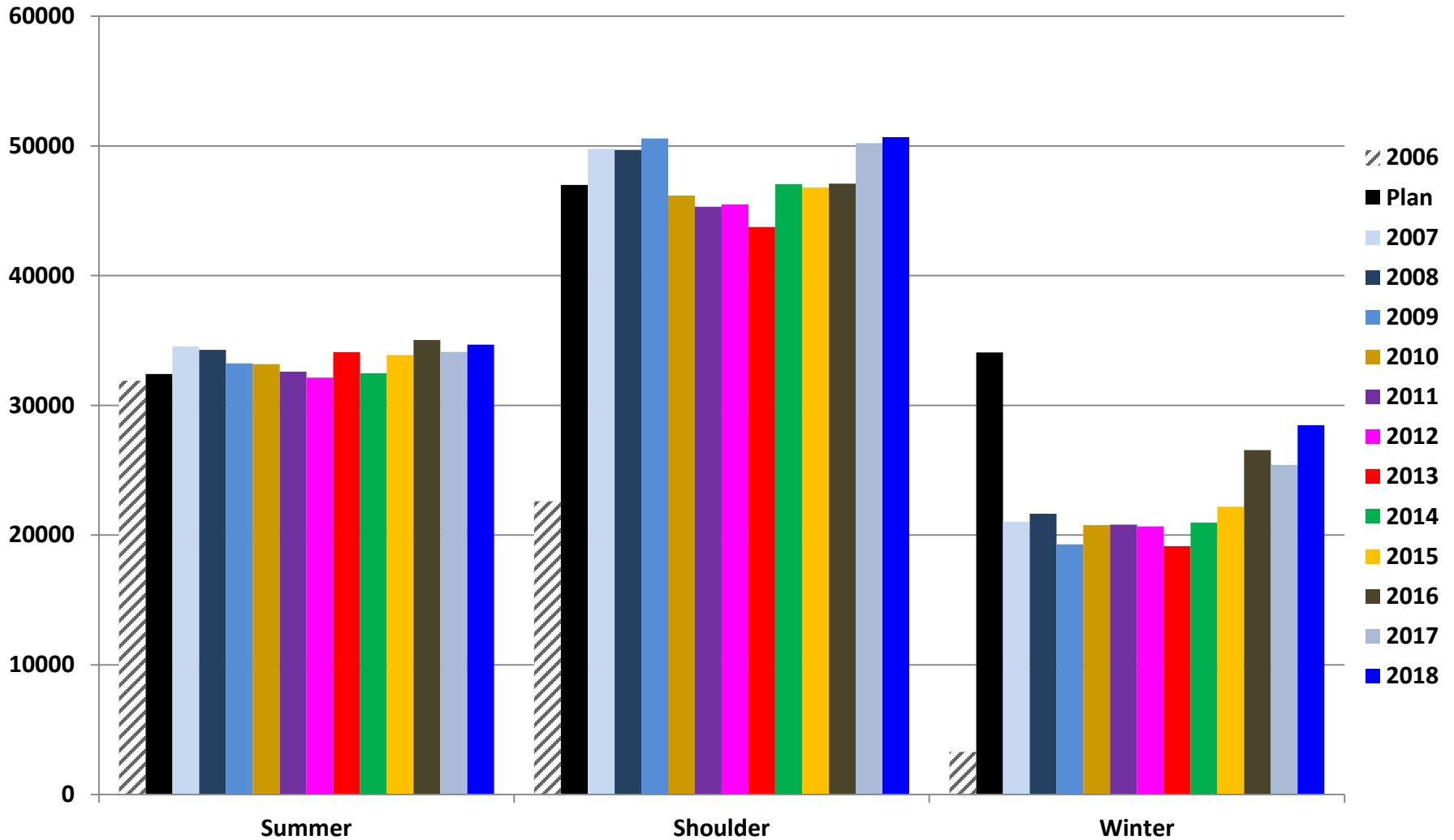

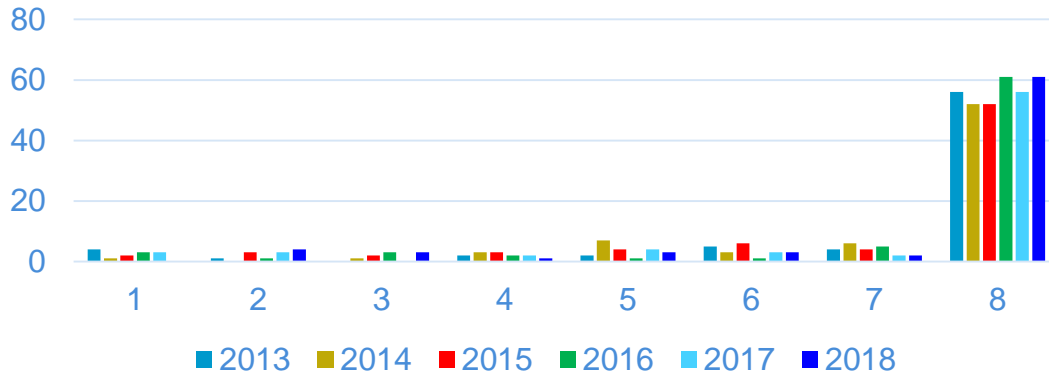

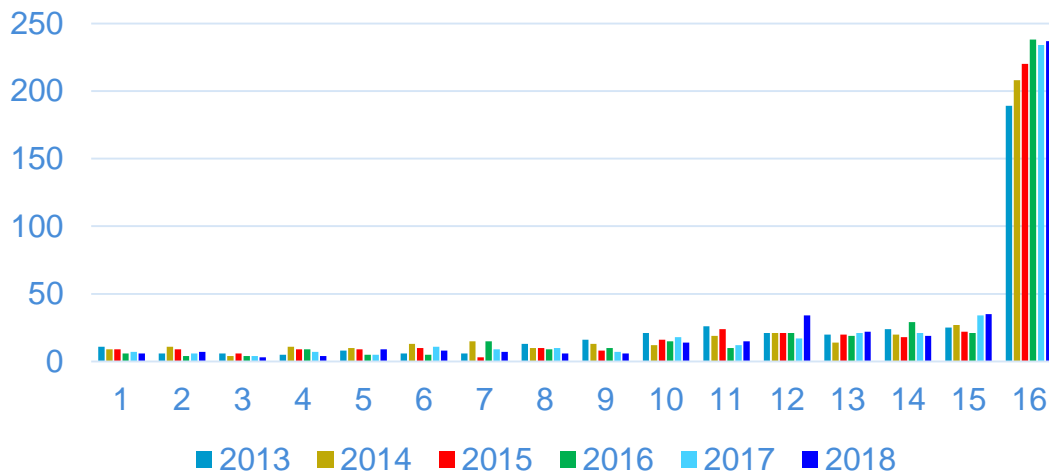

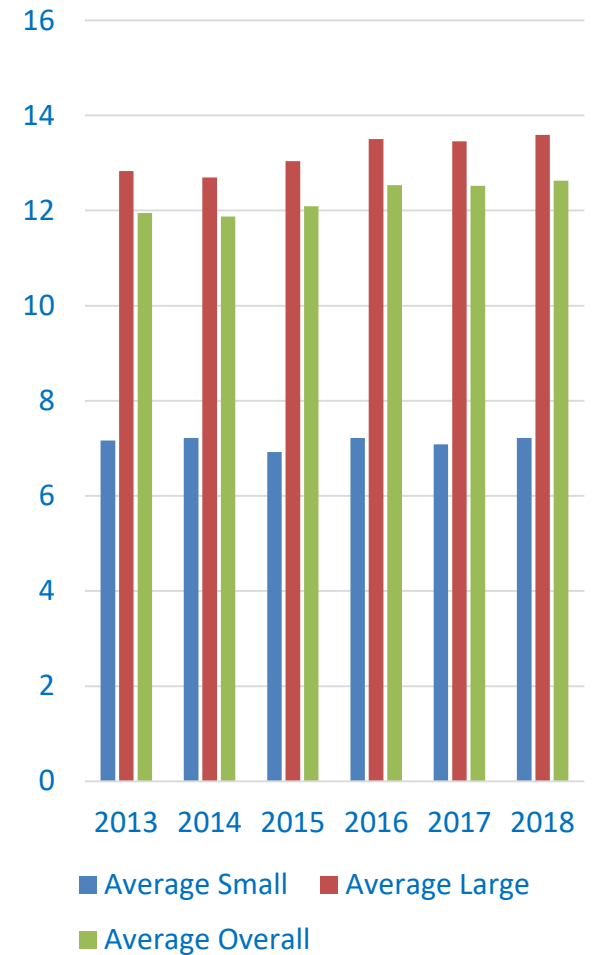
Small Sized Trips (1-8 p)

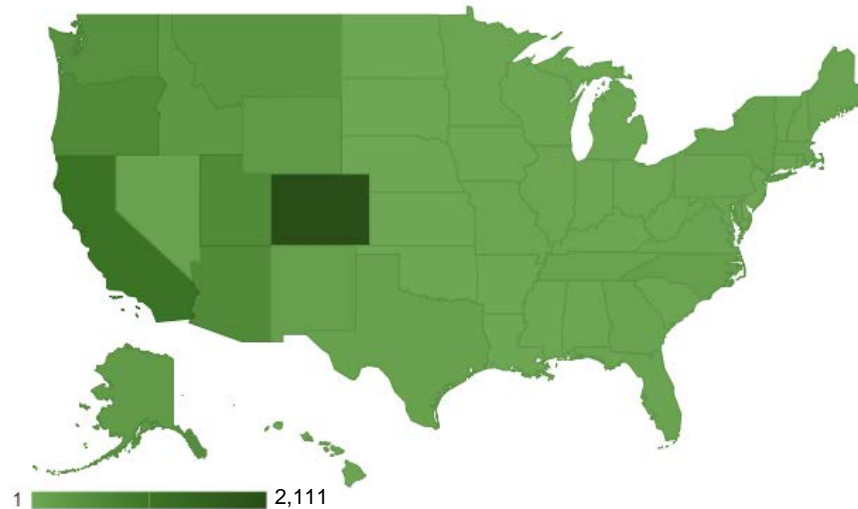

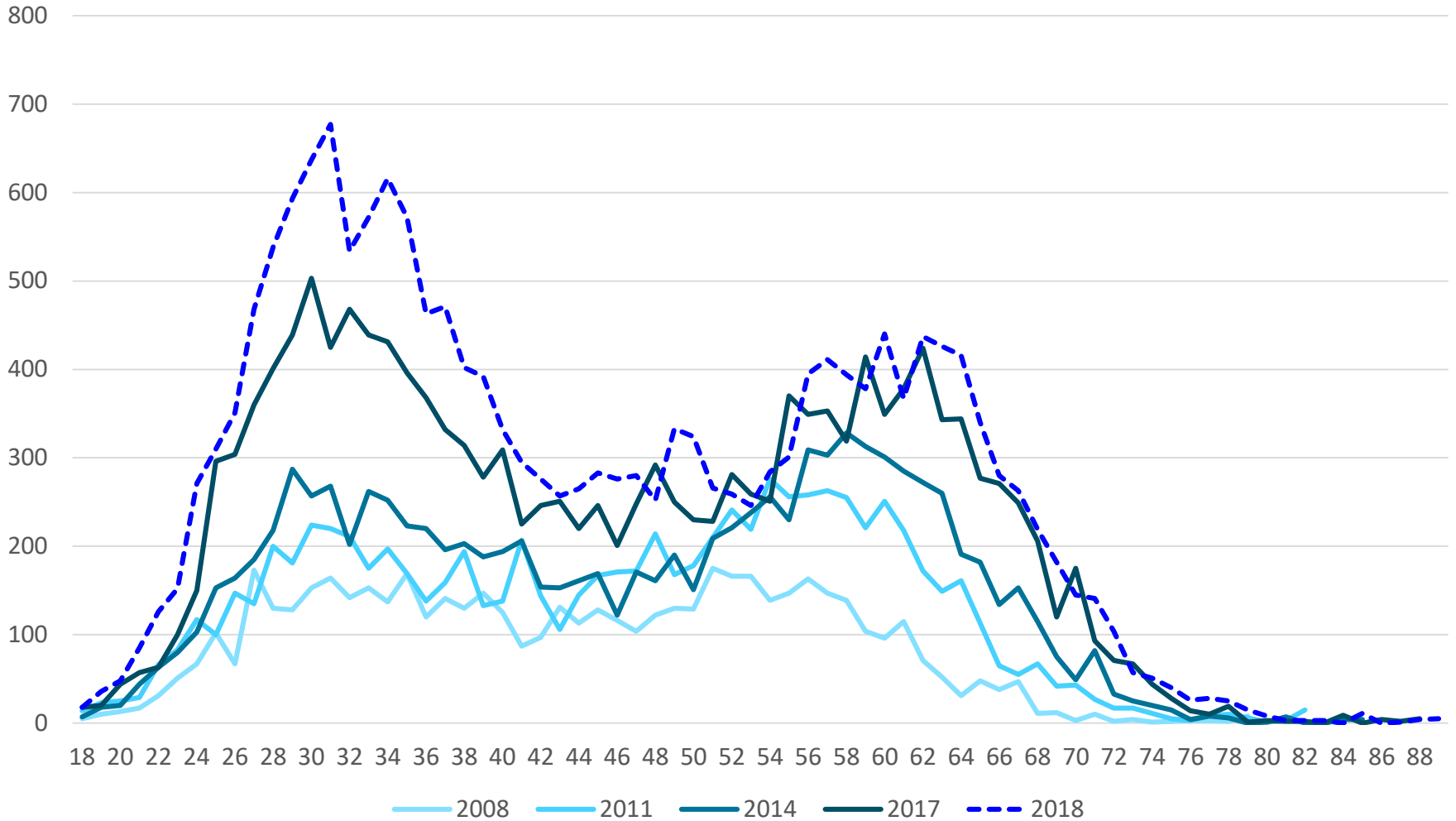

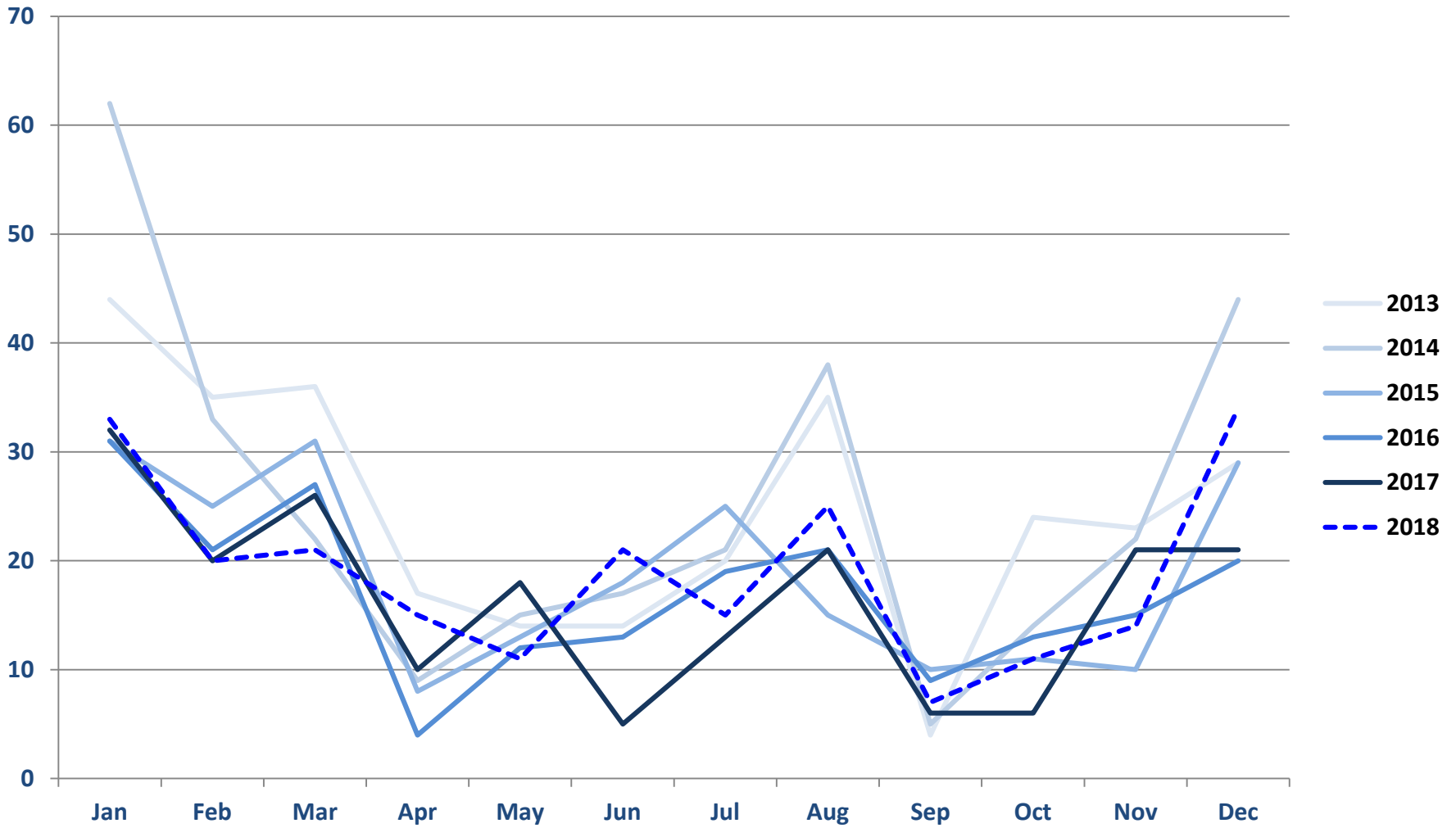

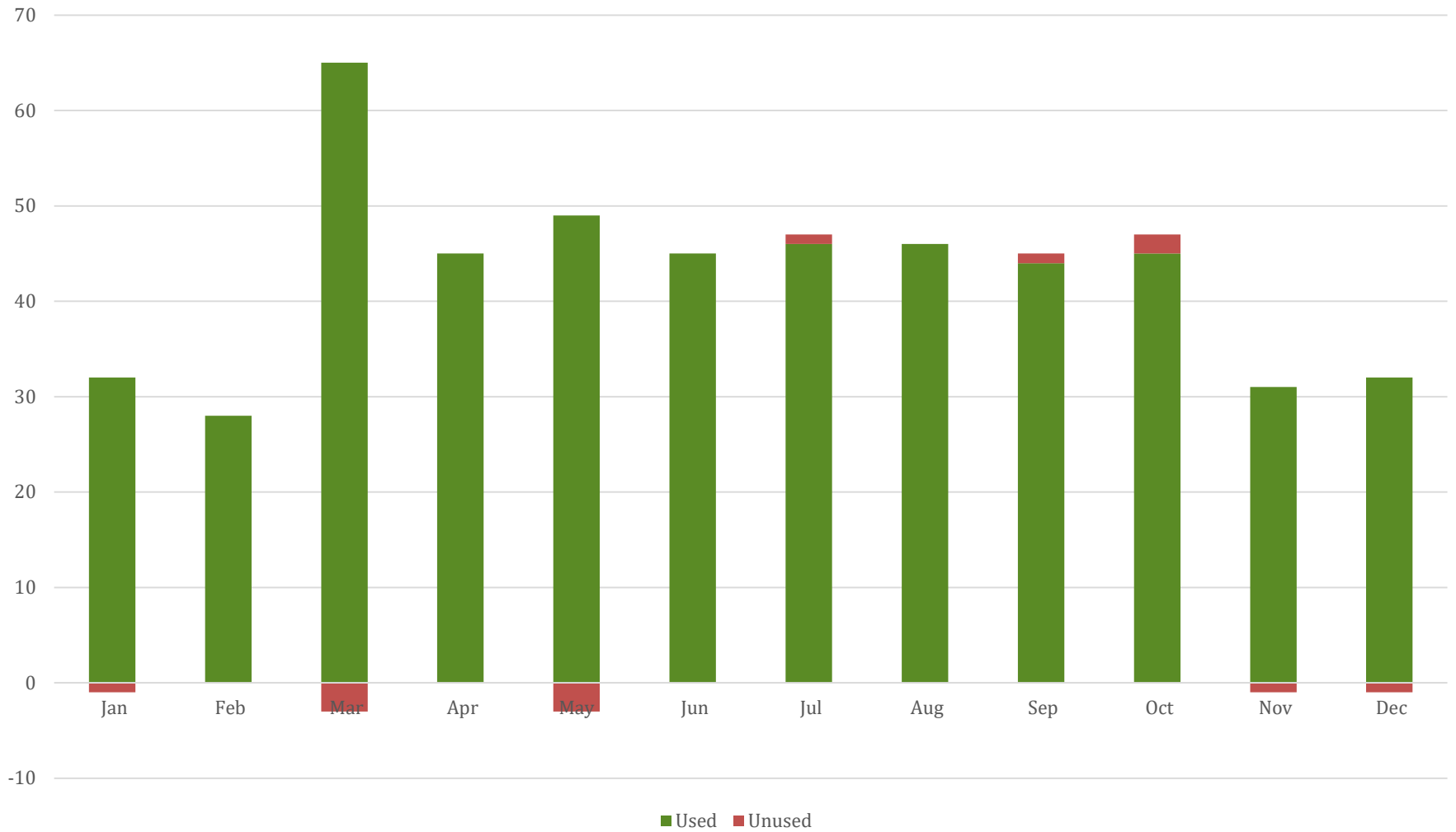

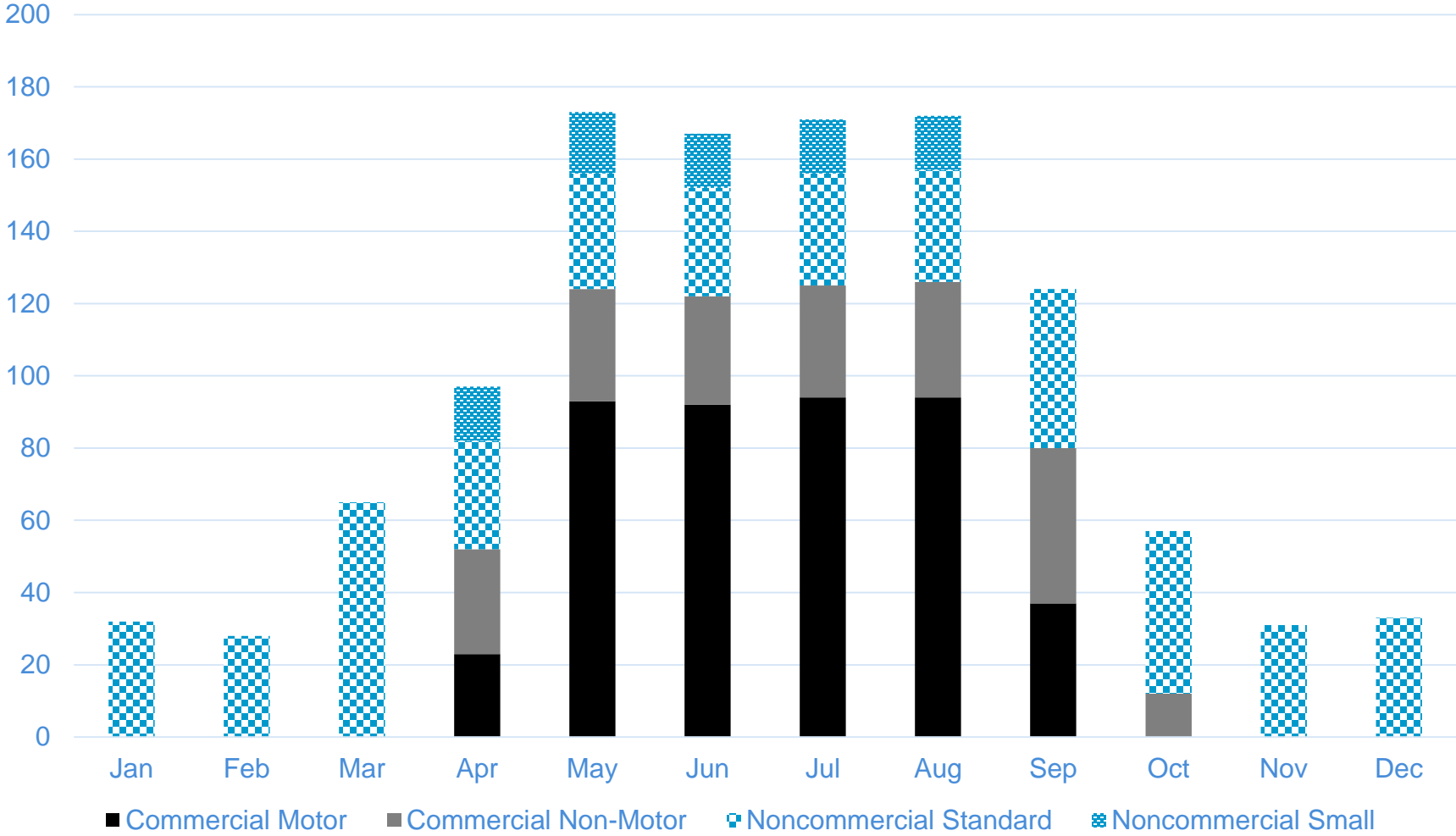

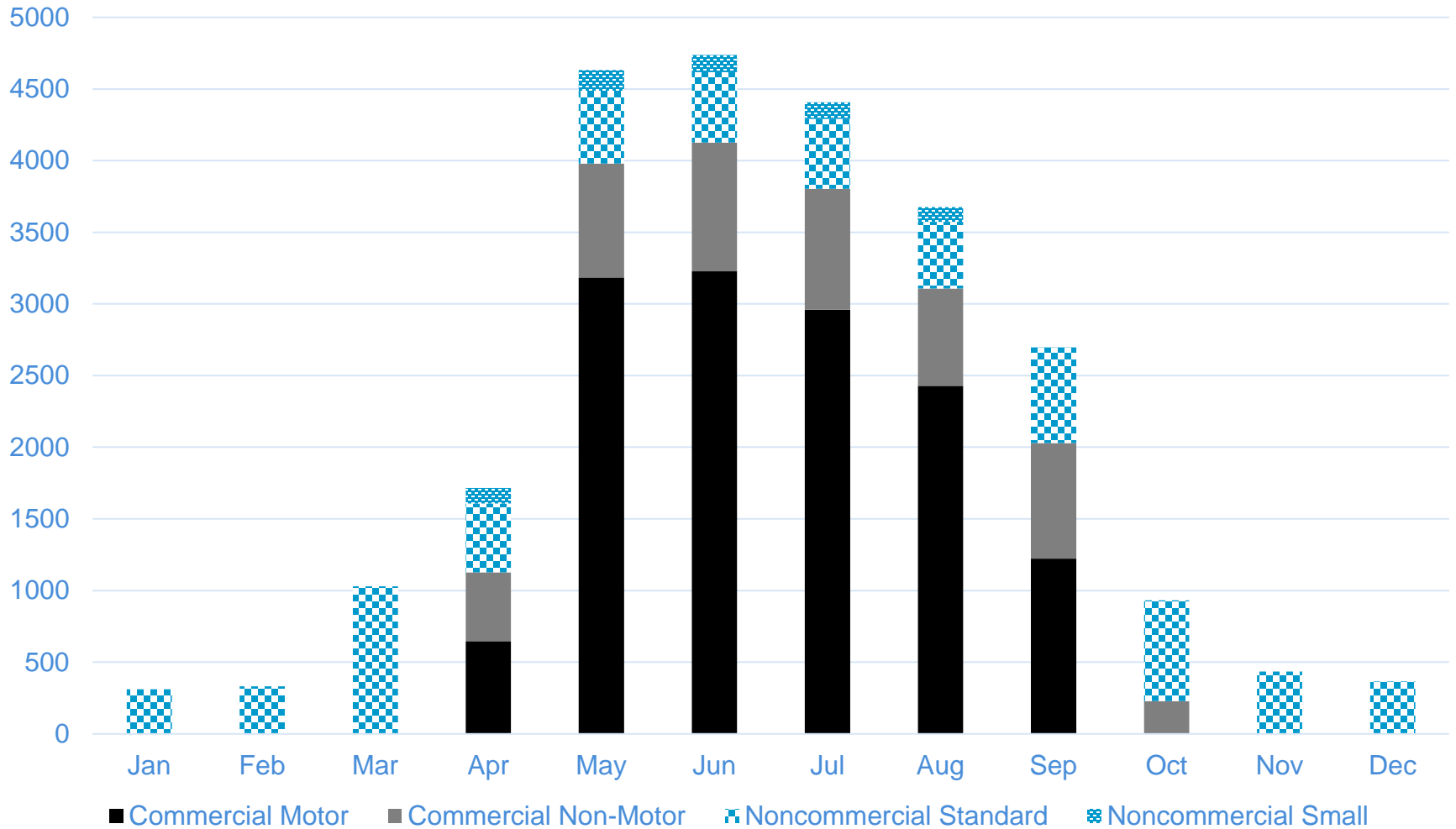

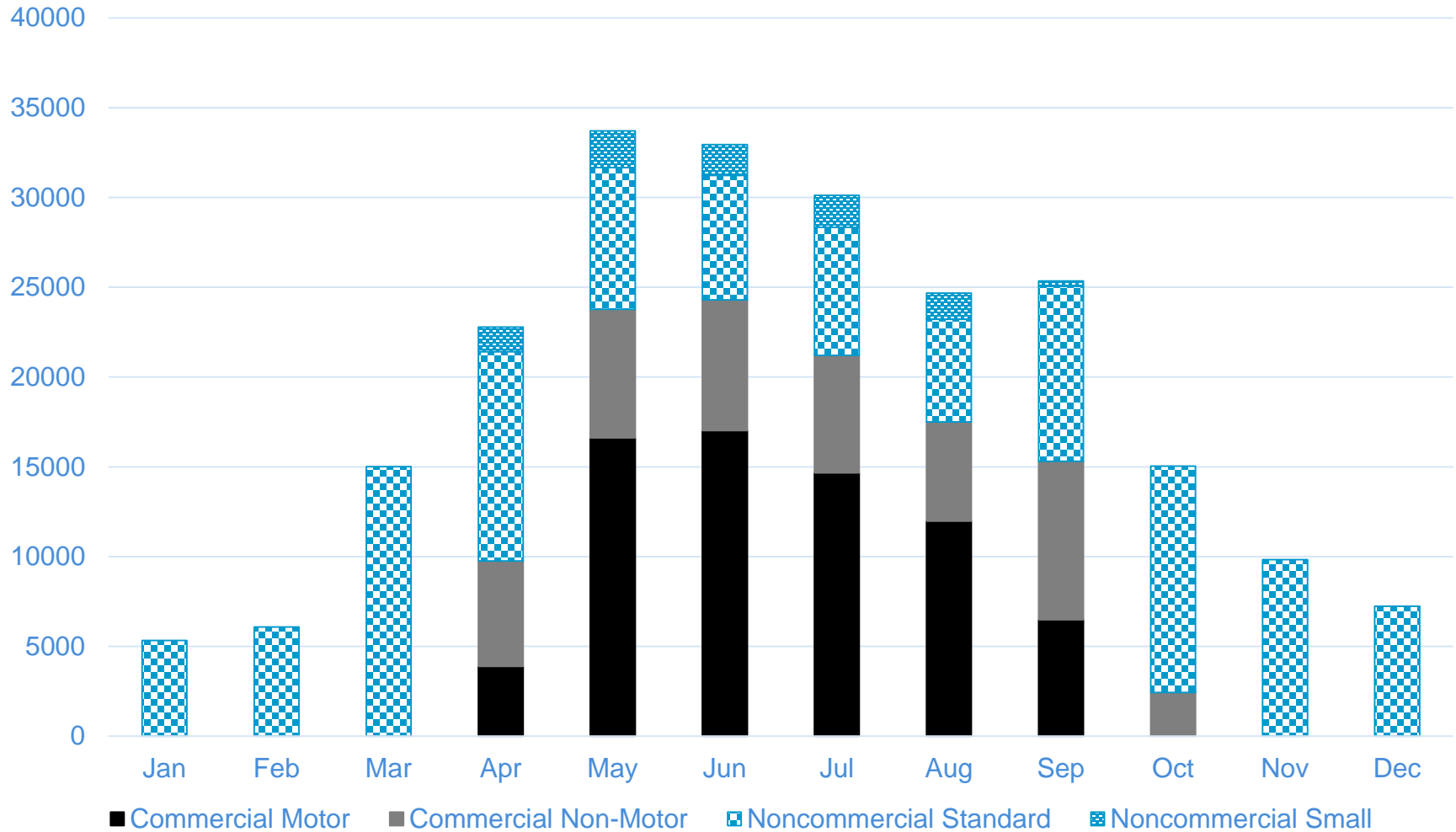
River – Lees Ferry to Diamond Creek Commercial + Noncommercial – Trips in 2018



River – Lees Ferry to Diamond Creek Commercial + Noncommercial – Passengers in 2018



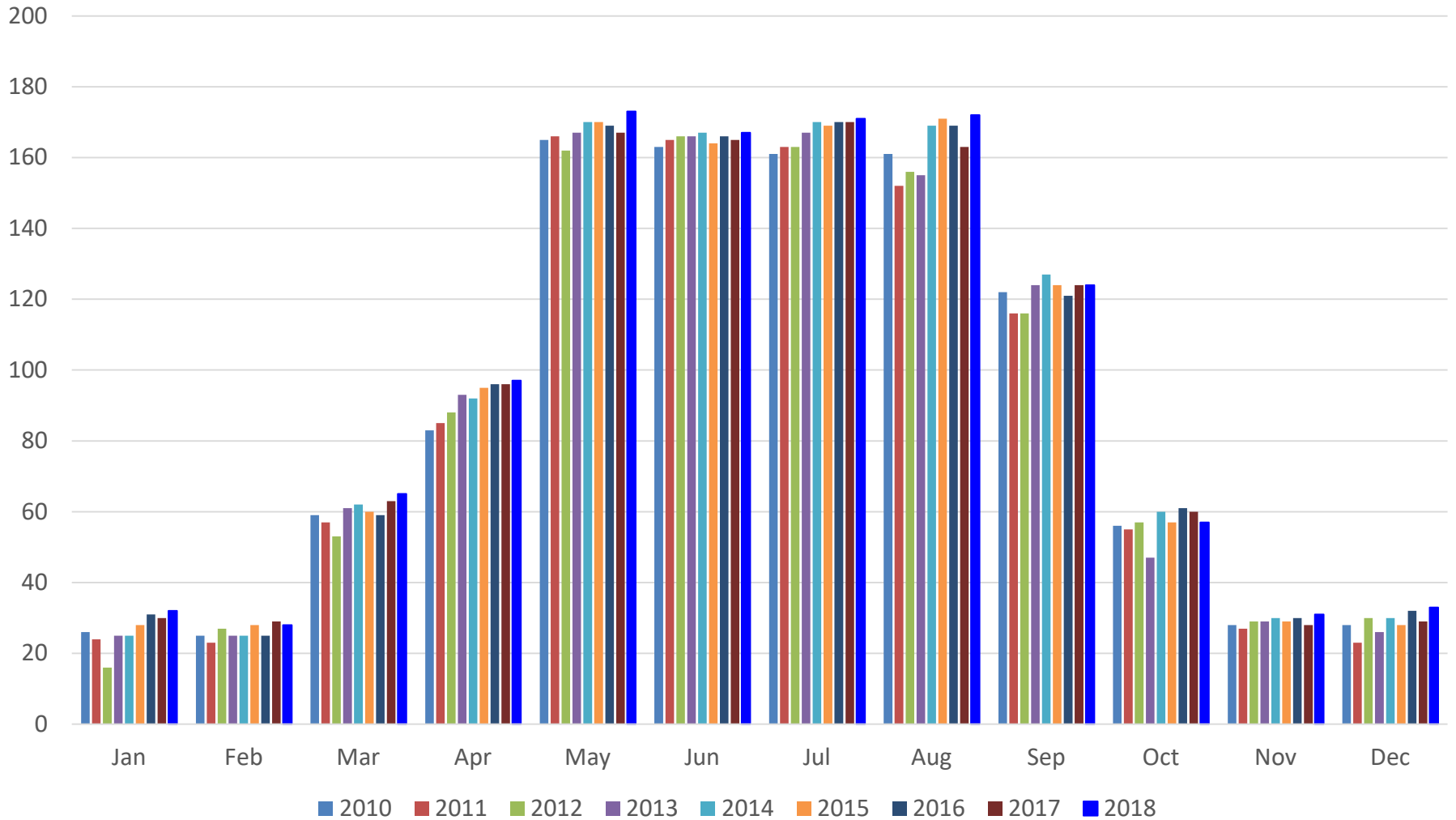

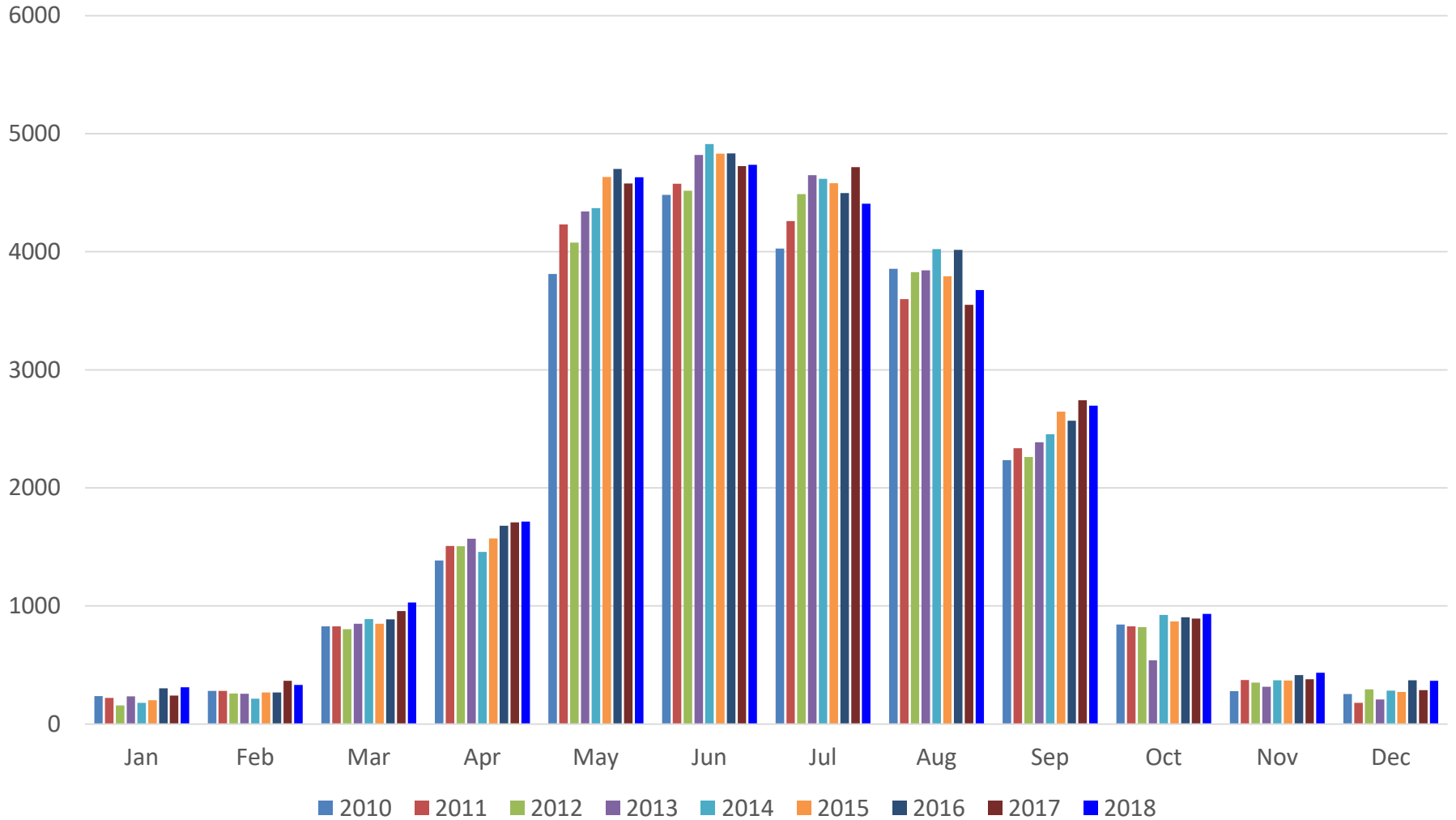

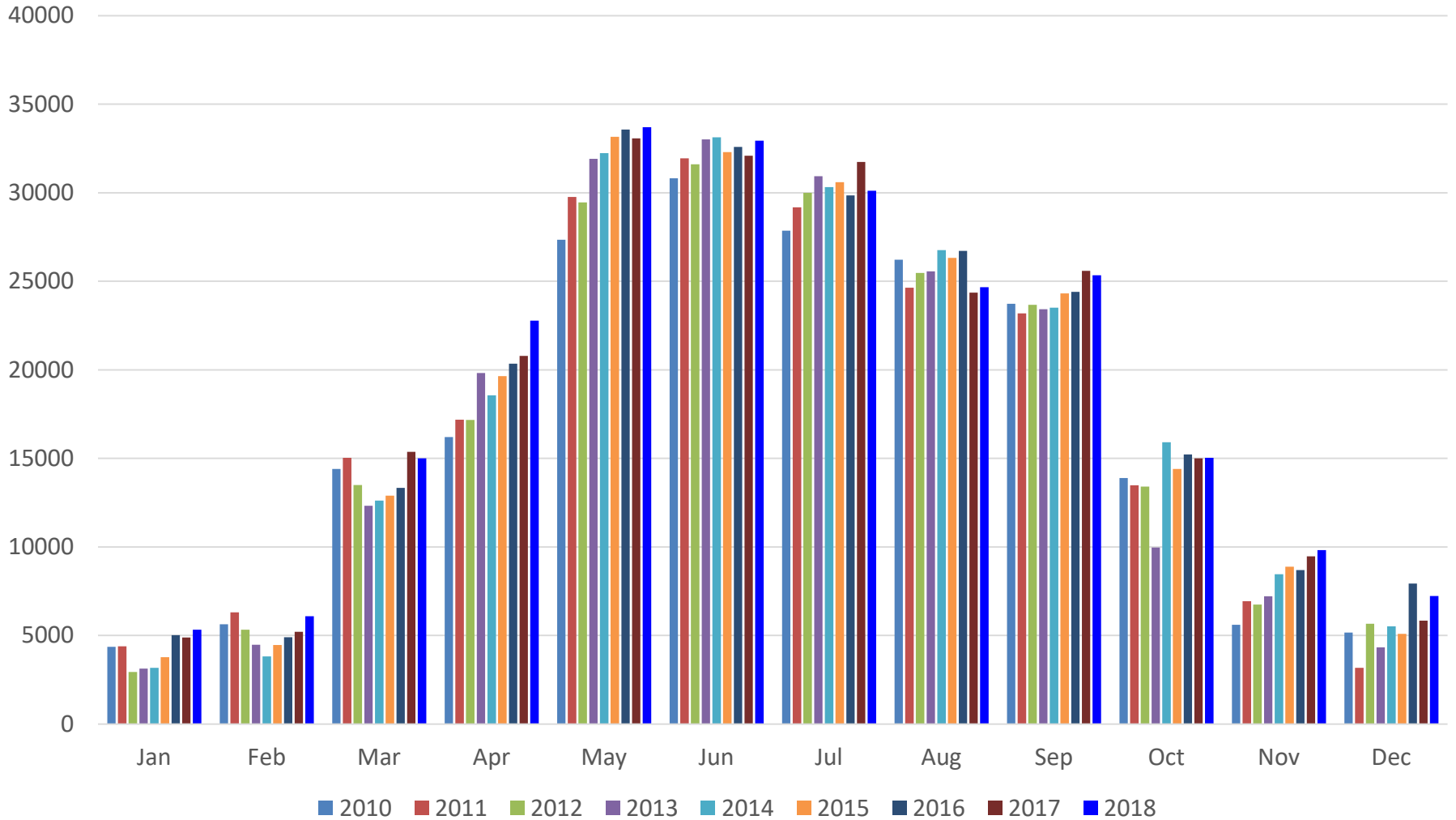
River – Lees Ferry to Diamond Creek Commercial + Noncommercial – Trips by Month



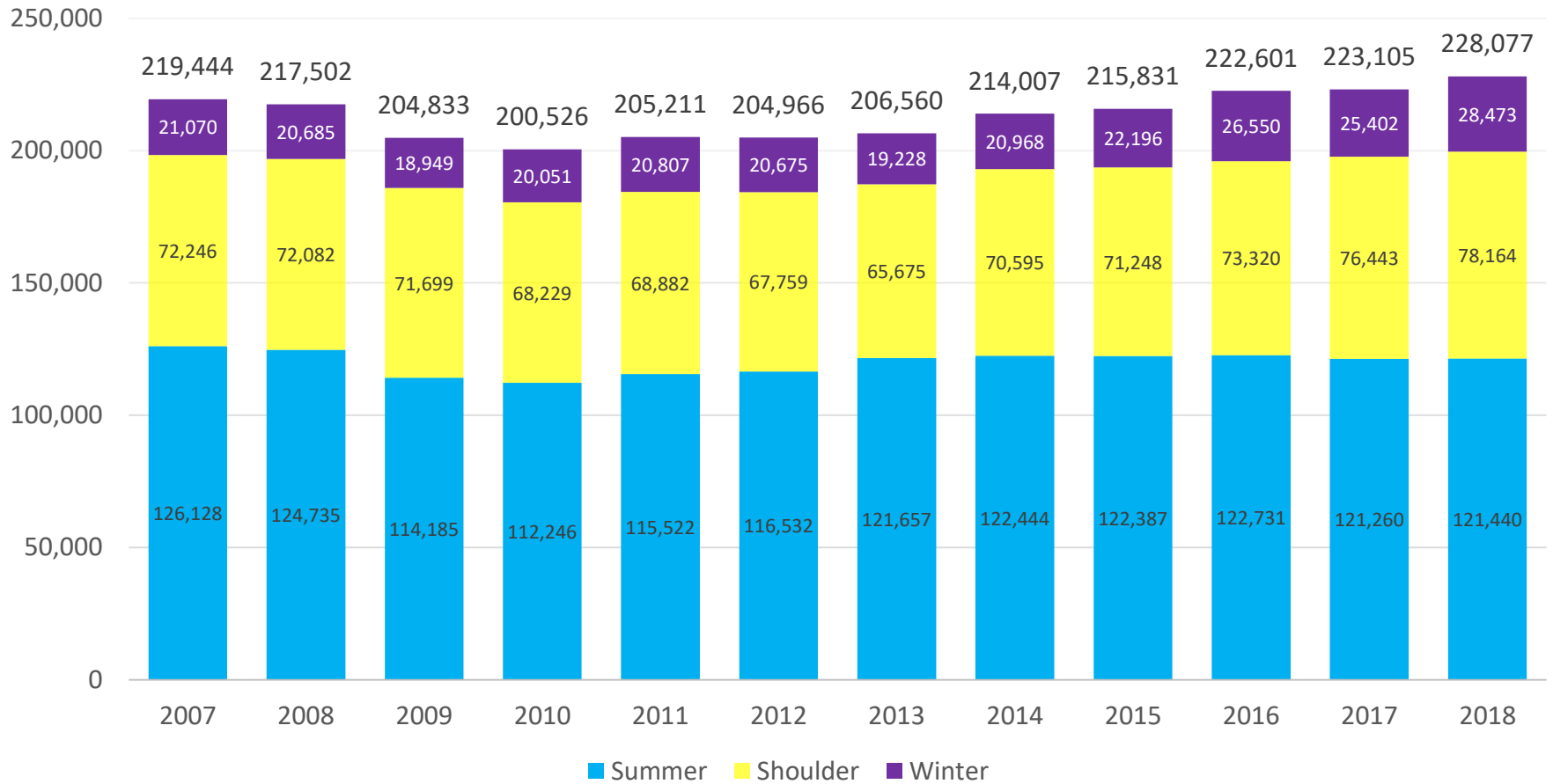
River – Lees Ferry to Diamond Creek Commercial + Noncommercial – Passengers by Month



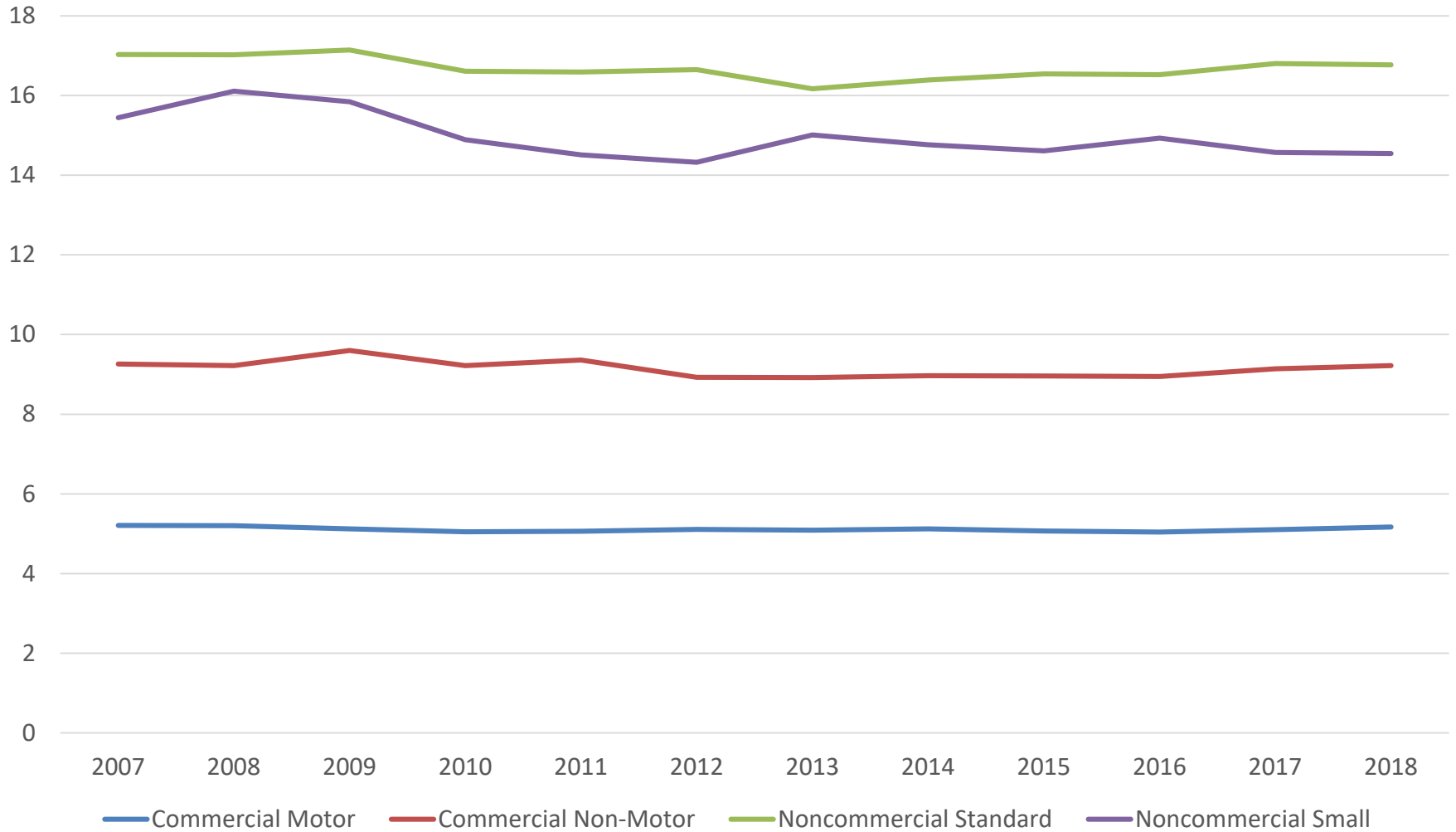

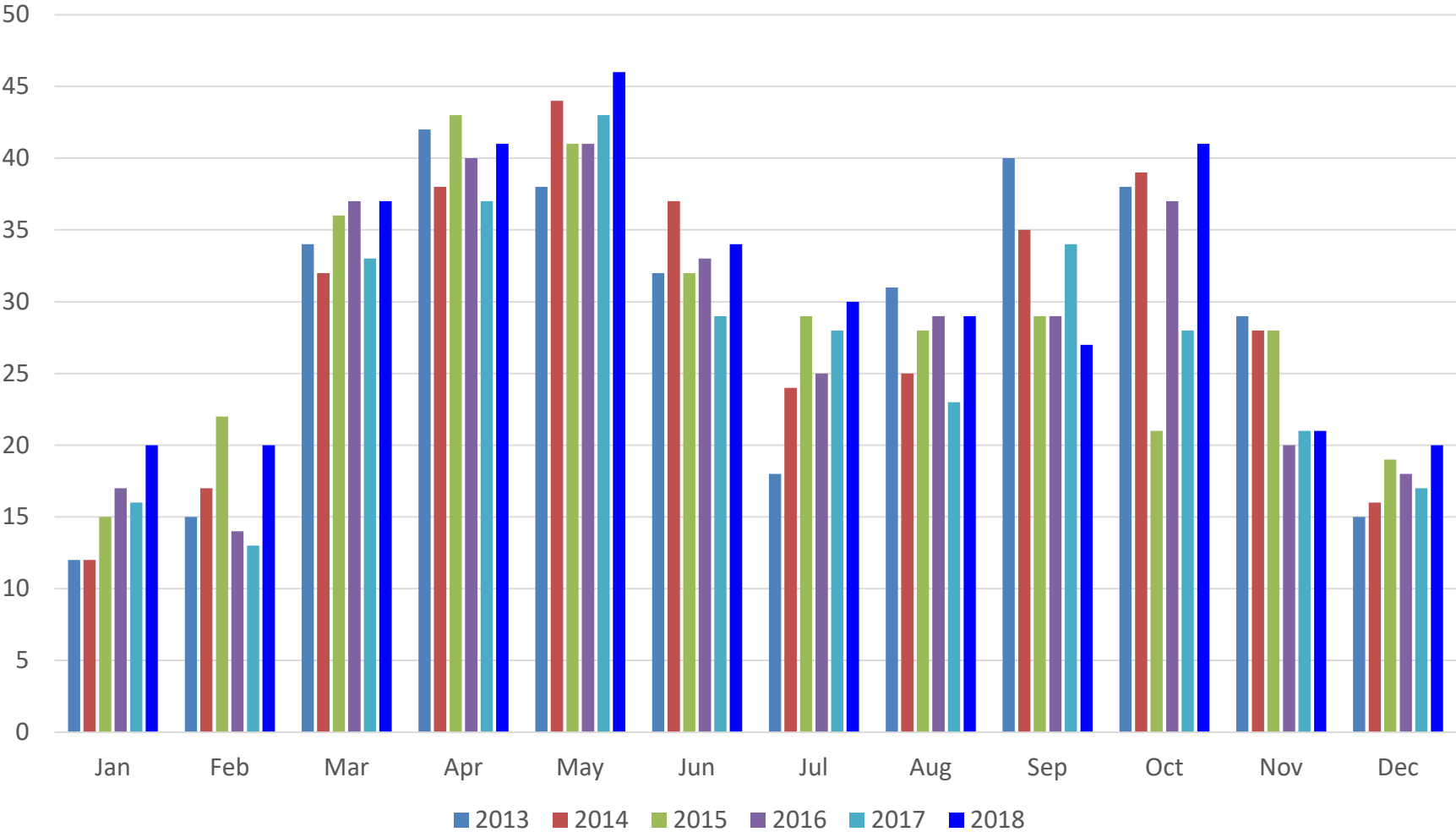

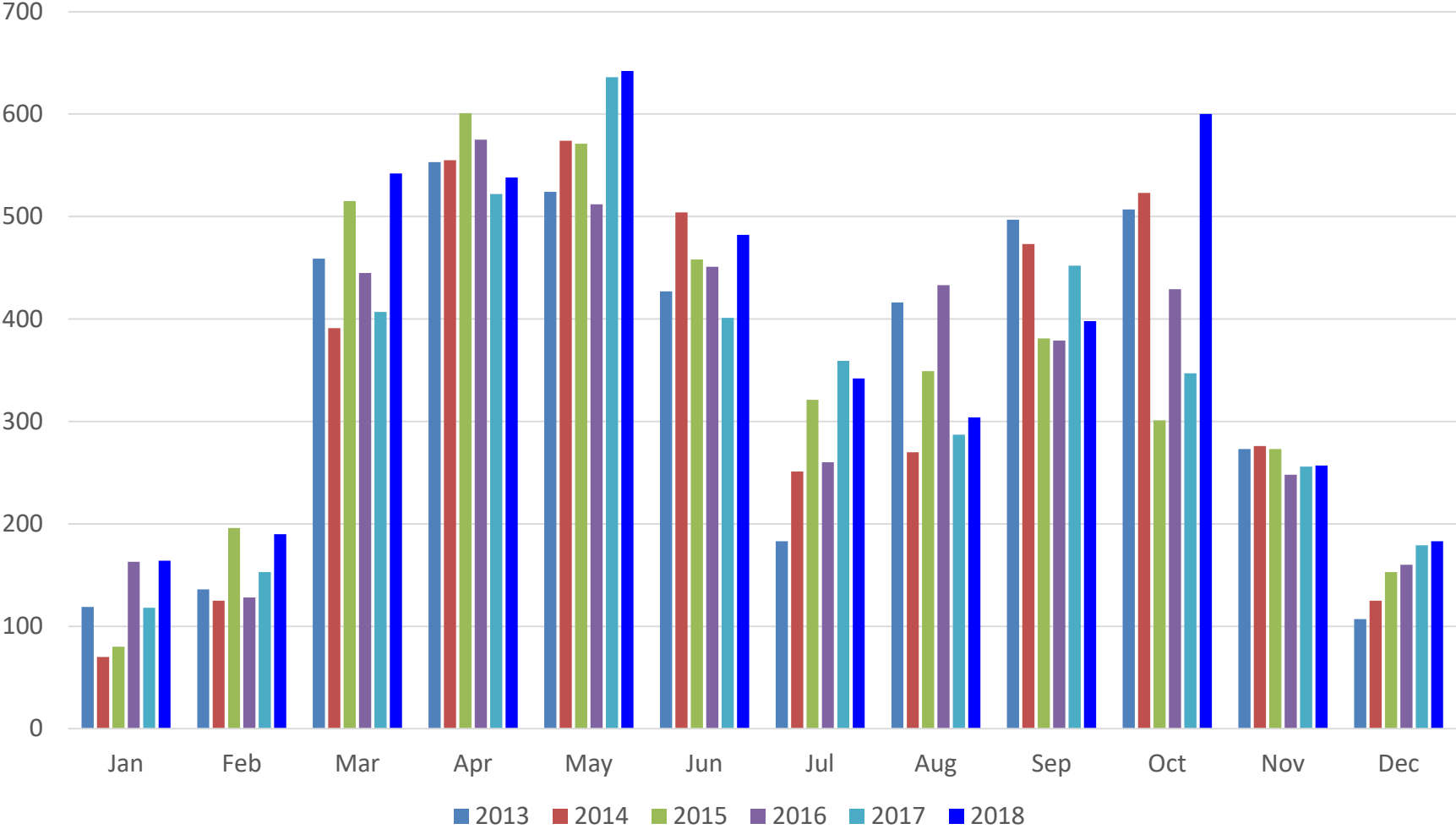

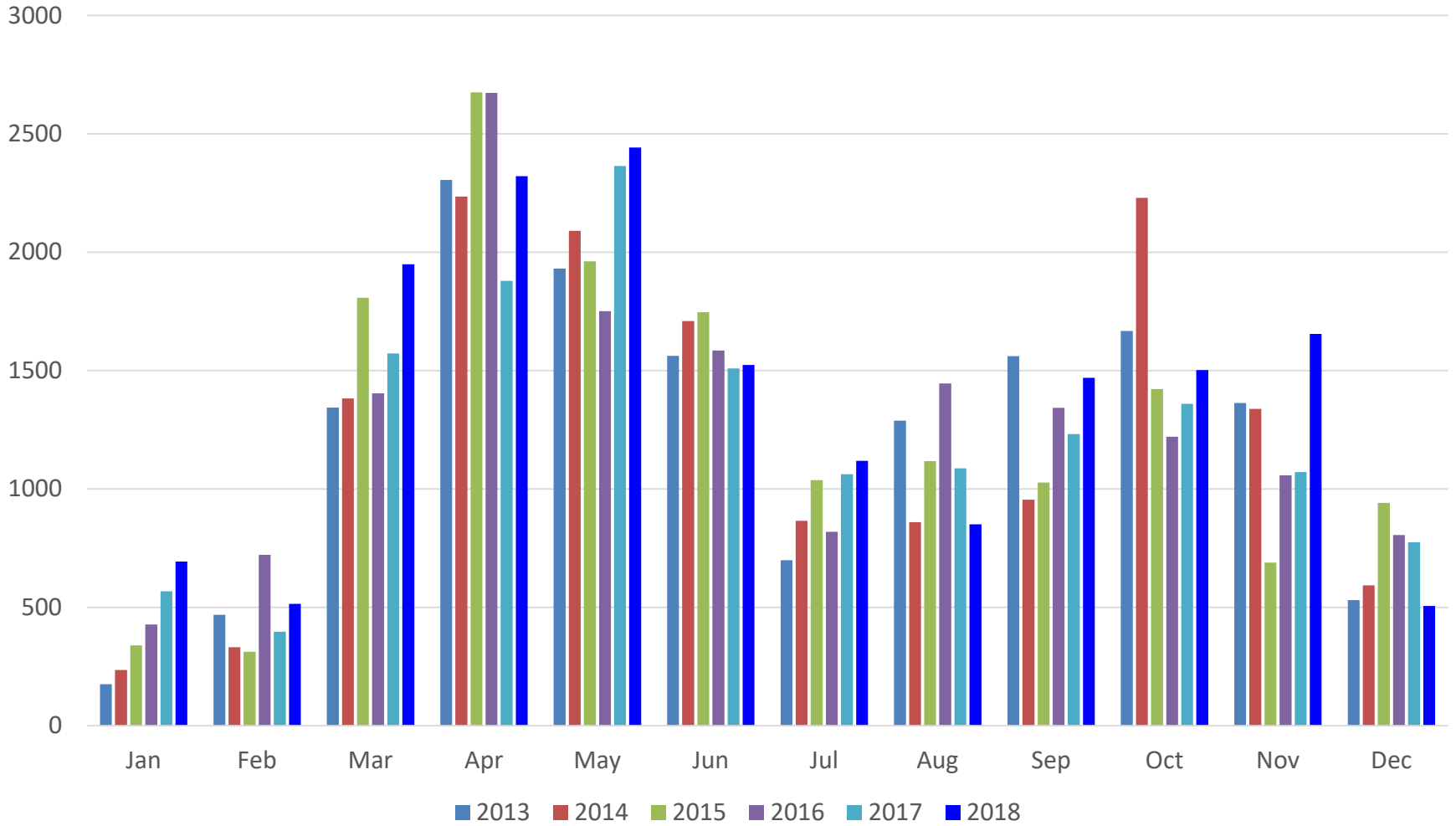
River – Diamond Down Noncommercial – Trips
