Project exhibits and copies of the Draft Environmental Impact Statement will be available at both public hearings. Study team members will also be available to discuss the project and answer your questions.

Public Hearing Process: How to Submit Your Comments

The following guidelines have been established by the Park to ensure that your comments are recorded during the Public Hearing in a fair and organized manner.

- Meeting attendees who would like to speak publicly during the hearing must sign up at the registration station no later than one hour prior to closing of the hearing.
- Prior to speaking, you will need to **complete a Speaker Card at the Speaker Station** to receive a speaking number.

- The Facilitator will call names in the order of the numbers assigned to each Speaker Card.
- When your name is called, you may approach the podium and 1) state your name for the record, and 2) state your comments and/or concerns.
- You will have a **3- minute time limit** to speak. There will be no additional time provided for people speaking on behalf of a group. You will only be allowed to speak one time. If you are speaking for someone else, you will not receive additional time, and must provide their comments within your 3- minute time limit.
- You will be signaled at 30 seconds prior to the end of the 3- minute timeframe. At the 3- minute mark, you will be asked to allow the next person to speak.

Court Reporters

Court reporters will transcribe all public hearing comments provided during each speaker's 3- minute timeframe. For anyone who prefers not to speak publicly or would like additional time to speak, court reporters will be available throughout the Public Hearing in the Open House area. Court reporter transcripts and written comments received prior to the end of the comment period deadline will receive equal consideration to those presented at the Public Hearing.

Preparing Your Comments

Please consider the following suggestions to help your comments be clear and effective:

Please Participate

Your comments will only be known if you participate by speaking at the public hearing, either publicly or to court reporters, or if you provide written comments.

Be Specific and Explain Your Comments

Clearly state your concerns with specific statements. Support your statements with facts and/or references when possible.

Meet the Deadline

All recorded and written comments received or postmarked by **May 11, 2006** will be incorporated into the EIS process.

Understanding the Layout of the DEIS:

The DEIS has two volumes. Volume I is the main document. It includes a Summary of the document, a section that defines acronyms and abbreviations used in the text, and a glossary to help in understanding the content of the DEIS. Volume II includes appendices that provide additional information and support the findings in the main document. Both volumes include a variety of figures and tables that depict and summarize information provided in the text.

Understanding the Issues:


The Summary provided in Volume I provides a general overview of the issues addressed in the DEIS. Detailed information related to the information in the Summary is provided throughout Volumes I and II.

Navigating the DEIS:

A detailed Table of Contents and lists of all of the figures and tables provided in the DEIS is located following the Summary section in Volume I.

Understanding the Impacts:

The DEIS documents the potential impacts of all project alternatives based on information known to date. Detailed mitigation plans will be developed for the alternative selected for implementation. During the final design phase, additional NEPA analysis may be required if impacts are found to be different than those already identified in the DEIS.



Planning Process Update – What’s Next?

- Review of DEIS and Appendices by the Public
- Collect and analyze public and agency input
- Respond in the FEIS to substantive comments received at the Public Hearings and during the DEIS comment period
- Prepare and publish the FEIS
- Prepare the Record of Decision
