## INDIANA DUNES NATIONAL LAKESHORE DUNEWOOD CAMPGROUND INFORMATION

Facilities:

79 campsites: 54 conventional drive-in sites; 25 walk-in sites. No electric hookups; restrooms and showers are available. All facilities are accessible to the mobility-impaired.

## Attractions &

Services:

Lake Michigan and the beach are located 1.5 miles north of the campground. The National Lakeshore Visitor Center, with exhibits, orientation program, and bookstore is located two miles west of the campground at the intersection of U.S. 12 and Kemil Road. A gas station and convenience store are located 1/4 mile north of the campground at the intersection of U.S. 12 and Broadway. A South Shore Railroad station, with frequent passenger service to Chicago and South Bend, is located on Broadway, 1/4 mile north of the campground.

Season:

Open year-round

Fees:

April through October: Conventional, \$10.00 per day; Walk-in, \$8.00 per day. Fees reduced 50% during off season.




## FEDERAL LAW AUTHORIZES THE FOLLOWING PASSES AND PASSPORTS:


Golden Eagle Pass: An Annual Entrance Fee Pass. Allows free entry to all Federal areas when an entrance fee is charged. Cost is \$25.

Golden Age Passport: A free lifetime permit for people who are 62 years of age or older. Provides a 50% discount on all daily recreation use fees, including camping. The discount for camping applies only to the campsite occupied by permittee.

Golden Access Passport: A free lifetime permit issued to persons regardless of age who are blind or permanently disabled. This permit provides a 50% discount on all daily recreation use fees, including camping fees.

Golden Passports are available at the visitor center during normal business hours.





## **DUNEWOOD CAMPGROUND REGULATIONS**

- 1. Each camping group must register and pay the fee each day at the registration station. Checkout time is 2 p.m. The registration receipt must be displayed on your campsite post. (See registration board for refund instructions.)
- 2. The camping group is limited to eight people/two vehicles (one RV or two tents) per site. Campsites may not be reserved. The limit of stay is 14 consecutive days.
- 3. All tents must remain on the camping pad. Vehicles and trailers must remain on the pavement. Bicycles may be walked to the walk-in campsites.
- 4. Pets must be under physical control, on leash (6' maximum), or caged. Livestock are prohibited.
- 5. Campfires are permitted in provided grates only. Wood gathering and the cutting or removal of vegetation are prohibited. Driving nails into trees or hanging hot lanterns on trees is prohibited.

CAUTION: HIGH WINDS MAY CAUSE TREE LIMBS TO FALL CAUSING PROPERTY DAMAGE OR INJURY.

- 6. Leveling and/or digging of campsite is prohibited.
- 7. Quiet hours are enforced: 10 p.m. to 6 a.m. Generators and audio devices may not disturb other campers.
- 8. Alcoholic beverage regulations are enforced. The possession or consumption of alcoholic beverages by persons under 21 years of age is prohibited.
- 9. Bathing or washing of any kind at water outlets is prohibited.
- 10. Disturbing, hunting or capturing wildlife is prohibited.
- 11. All refuse and trash must be placed in provided containers.
- 12. Weapons, traps, and fireworks are prohibited.
- 13. The speed limit in the campground is 15 MPH.
