

# Shenandoah

NATIONAL PARK, VIRGINIA

To know Shenandoah National Park, to discover its secrets, take time to stop, look, listen, and explore. For adventure, leave your car at one of the overlooks or visitor-use areas, and hike or ride horseback along the trail. Between Skyline Drive and Shenandoah's boundaries are miles of ridges and valleys, hills and hollows, laced with sparkling streams and waterfalls. Trout lurk in shadowed pools, and wild gardens of rock, vines, shrubs, and wildflowers nestle only a short walk from the busy roadway.

Shenandoah National Park lies astride a spectacularly beautiful part of the Blue Ridge, which forms the eastern rampart of the Appalachian Range from Pennsylvania to Tennessee. The Shenandoah River, from which the park's name is derived, lies to the west, flowing northeastward between the Blue Ridge and the Allegheny Mountains. Massanutten, the 40-mile-long, straight-profiled mountain you see from many Skyline Drive overlooks, lies between the North and South Forks of the Shenandoah. To the east of the Blue Ridge is rolling Piedmont country.

From the mid-eighteenth century on into the 1900's the hollows, ridges, and slopes that now constitute the national park were the home of mountain people. These hardy folk eked out a marginal existence by growing corn, beans, cabbages, and apples; by raising chickens, hogs, and cows; and by producing from the bounty of the forest and the harvest of their stony fields such market commodities as tanbark, honey, moonshine, and furs. Theirs was a highly self-sufficient culture. They developed their own techniques for smoking meats, rendering hogs, preserving vegetables and fruits for winter use, and making household furnishings and farm implements. They devised their own recreational pursuits, created their own music, and passed on their traditions from generation to generation.

During the first decades of this century many of the mountain people left this land, which had become steadily less productive, in search of an easier life in the lowlands. The lumber companies had depleted the forests; most of the game was gone; the soil was worn out from misuse and much of it washed down the slopes; and cash was always scarce. When the plans for a new 300-square-mile national park to be carved out of the Blue Ridge were taking shape, it was necessary to make provision for the future of the remaining mountaineers. New communities were established in the valleys below the Blue Ridge, and the fam-

ilies moved down into Government-financed homes that were closer to schools, jobs, and the amenities of civilization.

With improvement in the economic lot of the mountain folk, the crafts they had developed over generations to enable them to exist in their isolated and harsh environment came into disuse. Today only a few old-timers retain the skills that enabled them to fashion finished products from the raw materials of the mountains, using only their hands and their homemade tools.

Following establishment of the park, cessation of timber-cutting operations, and relocation of the mountain people, nature rapidly began to heal the scars of man's long exploitation of the land. Vegetation soon masked the stone walls, rail fences, and rusting barbed wire; and pines, locusts, and other pioneer forest trees reclaimed the cut-over forests and worn-out fields. Today few signs remain as evidence of the mountain culture. Here and there old apple trees bear blemished fruit; but the crop is harvested by black bears and white-tailed deer. Raccoons, opossums, skunks, squirrels, turkeys, and woodland songbirds again abound, and beavers have returned to the fringes of the park. On the other hand, animals adapted to grassy or brushy environments, such as the cottontail, quail, and red fox, declined in numbers as the pastures, cornfields, and farmyards were gradually taken over by the new forest. The landscape, even without the late, lamented American chestnut, is regaining the aspect of the pristine scene that greeted the settlers who moved west from the coastal plain or east from the Shenandoah Valley a century ago.

By far the greatest number of visitors enjoy Shenandoah's scenic beauty from the 105-mile Skyline Drive. Numerous parking overlooks along the drive present panoramas of the Piedmont and the Shenandoah Valley. The map in this folder is keyed to concrete markers, numbered from north to south along the Drive to serve as your guide to park features, facilities, and services. These markers are placed every mile, but only on the mile. Example: **Milepost 31**. Features "between the posts" are shown in tenths of a mile. Example: **Panorama Restaurant, Mile 31.5**.

Shenandoah's two visitor centers, Dickey Ridge at Mile 4.6 and the Byrd Visitor Center at Big Meadows near Milepost 51, are open from early spring to late autumn. Each center offers short orientation programs, exhibits, and information

on the park. Maps, guides, pictures, slides, books, and pamphlets are on sale.

The folder, *Visitor Activities*, free at visitor centers, entrance stations, and concession lodges, tells where to meet ranger-naturalists for summer field trips, and the dates and hours of campfire programs at Matthews Arm, Skyland, Big Meadows, Lewis Mountain, and Loft Mountain. On your own, throughout the year, you can enjoy the self-guiding nature trails.

To learn what's going on in Shenandoah, check one of the park's 50 outdoor bulletin boards. Park rangers will help you with special questions or in emergencies.

## ACCOMMODATIONS

ARA-Virginia Sky-Line Company, Inc. (Box 727, Luray, VA 22835), a park concessioner, operates lodge and cottage accommodations for more than 900 guests in the Park's central district at Skyland, Big Meadows, and Lewis Mountain. Food service, gift shops, and service stations; and facilities for campers, such as grocery and camping-supply stores, shower and laundry buildings, ice and wood sales lots, and riding stables are located at various points along Skyline Drive. All facilities are operated in summer; some are available in spring and autumn. Services at Panorama (Mile 31.5) are available throughout the year. (Closed on Mondays and Tuesdays in winter and on Christmas.)

Another park concessioner, the Potomac Appalachian Trail Club (1718 N St., N.W., Washington, DC 20036), maintains five trail cabins for hikers. Advance reservations and keys must be obtained by mail from the club.

There are five campgrounds and seven picnic areas in the Park. User fees are charged for all campgrounds. Big Meadows Campground is open all year. Dundo Campground is reserved for organized youth groups.

## REGULATIONS

Maximum speed is 35 miles per hour. Lower speeds are posted in many areas. Commercial trucking on park business only. Vehicles must stay on public roads. Report all accidents to the nearest park ranger as soon as possible.

Stay on designated trails. Do not shortcut between zig-zags or switchbacks. Never hike alone; tell someone where you are going and when you will return. Bicycles and motor vehicles are prohibited on trails.

Collecting of souvenirs, picking of wildflowers, and acts of vandalism are prohibited.

Pets must be leashed and (except Seeing Eye dogs) are not allowed in public buildings.

A camping permit, required for all back-country camping, is available from rangers; at visitor centers and Park Headquarters; or by mail from the Superintendent.

Hunting with any kind of weapon is prohibited. Before entering the park, firearms must be made inoperative and packed away.

In order that more persons may enjoy a camping experience in the park, camping within the Park from June 1 through October 31 is limited to a total of 14 days.

Shenandoah National Park is a Federal Fee area. Fees are not refundable due to inclement weather.



All park animals are wild. Do not feed or approach them. Bears roam the park—keep a clean camp to protect yourself and your property.

## ADMINISTRATION

The administration offices of Shenandoah National Park are 4 miles west of Thornton Gap and 4 miles east of Luray, on Lee Highway (U.S. 211). If you have questions or comments about the park, send them to the Superintendent, Shenandoah National Park, Luray, VA 22835.

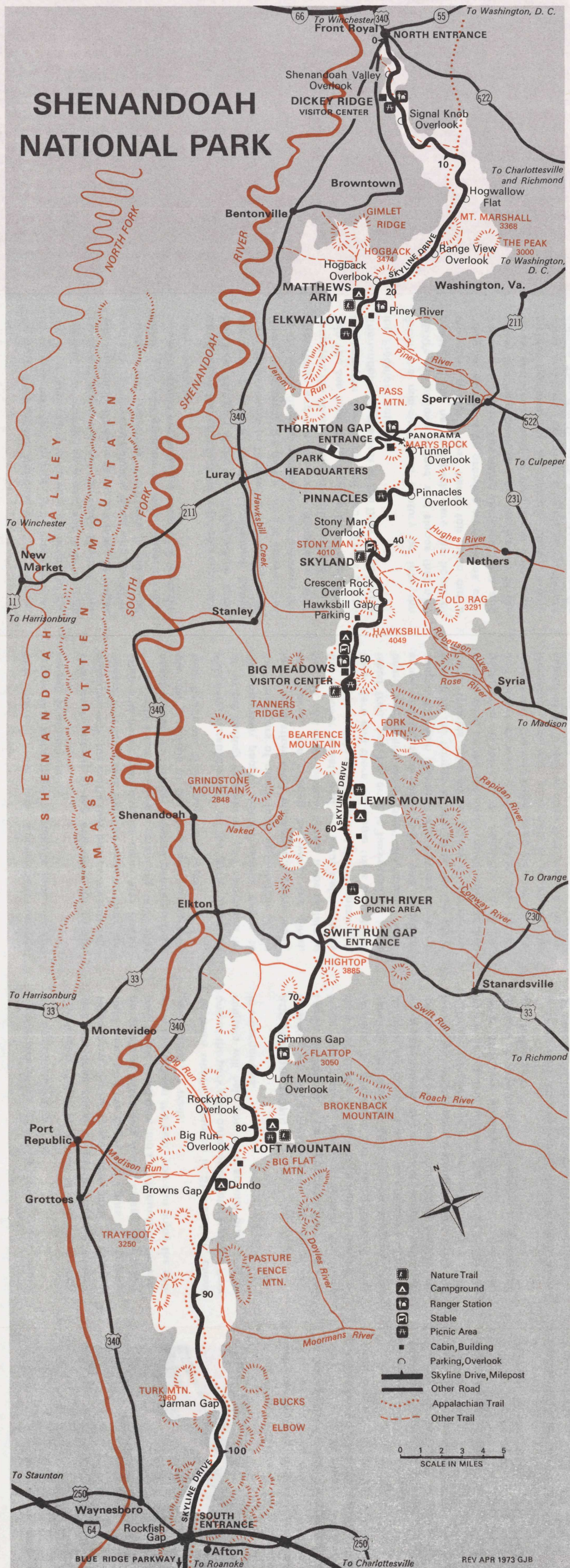

## MILE POINT OF INTEREST

- 0.0 Junction with U.S. 340, south of Front Royal (I-66-W Jct. 1 mi. north).
- 0.6 North Entrance Station.
- 2.8 Shenandoah Valley overlook. Across the valley is Signal Knob, Civil War communications post on Massanutten Mountain.
- 4.6 Dickey Ridge Visitor Center. Picnic area. Exhibits, programs, information. Sales outlet for park literature, slides, maps.
- 21.0 Hogback overlook. Eleven bends in Shenandoah River are visible on clear days.
- 22.3 Matthews Arm Campground. Tent and trailer sites. Trailer sewage disposal station and firewood. Hikes and campfire programs in summer. Nature trail.
- 24.1 Elkwallow. June-October. Picnic area, lunch, campers' store, souvenirs, gasoline.
- 31.5 Thornton Gap. U.S. 211 interchange. Entrance station. Panorama Restaurant open all year; gift shop and service station. Trail to Marys Rock. Park headquarters 4 miles west.
- 32.4 Marys Rock Tunnel through 660 feet of rock (13-foot clearance).
- 36.7 Pinnacles. Picnic area. Appalachian Trail junction.
- 39.1 Little Stony Man parking. Trail to sweeping view of Shenandoah Valley (1½ miles round trip).
- 41.7 Skyland Lodge. April-October. Dining room, gift shop, riding horses. Stony Man Nature Trail parking.
- 42.6 Whiteoak Canyon parking. Trail to falls (5 miles round trip).
- 44.5 Crescent Rock overlook. Best view of Hawksbill Mountain, highest in park.
- 45.6 Hawksbill Gap parking. Trails to 4,049-foot Hawksbill Mountain. Conducted hikes in summer.
- 46.7 Upper Hawksbill parking. Trail to Hawksbill summit (2 miles round trip).
- 50.5 Dark Hollow Falls parking. Trail to falls (1½ miles round trip).
- 51.0 Big Meadows. Byrd Visitor Center. Exhibits (on mountaineers), programs, information. Sales outlet for park literature, slides, maps. Hikes and campfire programs in summer.
- 51.3 Wayside and entrance to Big Meadows development. April-October. Coffee shop, campers' store, gift shop, service station.
- (1 mi. Big Meadows Lodge. Mid-May off through October. Dining room, gift shop, riding horses. Campground with trailer sites (open all year); picnic area. Showers, laundry, firewood, ice sales in summer. Trailer sewage disposal station. Swamp Nature Trail; campfire programs.
- 57.6 Lewis Mountain. June-September. Cabins, campground with trailer sites, picnic area, firewood. Campfire programs.
- 62.9 South River Picnic Area. Trail to falls (2½ miles round trip).
- 65.7 Swift Run Gap. U.S. 33 intersection.
- 78.2 Rockytop overlook, Big Run watershed, wild canyon scenery, trails.
- 79.8 Loft Mountain. Campground with trailer sites, picnic area. Trailer sewage disposal station. Campers' store, service station, showers, laundry, ice, firewood. Hikes and campfire programs in summer. Nature trails.
- 83.7 Dundo Group Campground; reserved for organized youth groups.
- 104.6 South Entrance Station.
- 105.4 Rockfish Gap. U.S. 250 intersection, and I-64. 5 miles to Humpback Rocks Visitor Center (Blue Ridge Parkway).
