CAMPGROUND RULES AND REGULATIONS

Please familiarize yourself with the following regulations. Thoughtful compliance will insure that Cottonwood Campground remains an attractive and orderly setting for your future use and enjoyment.

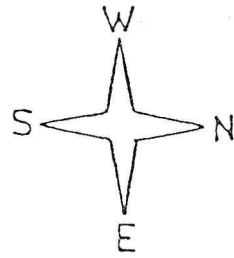
1. Campsites are available on a first-come, first-served basis. Campsites can not be reserved. When away from site, demonstrate your occupancy by displaying your current camping permit or exhibiting other evidence. To avoid resource damage to campsites, occupancy of any one site is limited to one family group or a group not totaling over six (6) individuals.
2. All wheeled vehicles, including trailers, bicycles, and motorcycles, must be operated or parked only on paved or gravel-surfaced roadways and pads. DON'T PARK OR DRIVE ON THE GRASS OR TRAILS.
3. PETS MUST BE KEPT ON A LEASH or otherwise physically restrained while in the park.
4. All drains on all vehicles must either be sealed or provided with receptacles, such as buckets, to catch waste discharge. Dumping of any waste on the ground is prohibited. Waste water disposal facilities are located in the side door of each campground comfort station. Commercial sanitary dumping stations are available in Medora.
5. Do not attempt to use any campground facility for utility hookups (water, electricity, etc.)
6. QUIET HOURS must be maintained from 10:00 pm until 6:00 am mountain time.
7. Portable generators must be equipped with an effective muffler. They may not be operated during the quiet hours (see item 6 above). The operation of any type of audio device, including radios or record players, in such a manner as to annoy others is prohibited.
8. Open fires are permitted only in the charcoal grates provided at each site. You must extinguish fires before you leave, even if you plan to be gone for only a few minutes. DO NOT LEAVE ANY FIRE UNATTENDED. Collection of park vegetation, dead or alive, is prohibited.
9. If another vehicle or camper unit attempts to move onto your assigned site, please notify the patrol ranger or any uniformed employee.
10. The campground is off-limits to horses and all riding activities.
11. The use of firearms or any other implement capable of propelling a projectile (bow and arrow, slingshot, air rifle, etc.), is prohibited. Similarly, the use of fireworks is not permitted.
12. State liquor laws are enforced within the park.
13. Camping limit is 14 days.

INSTRUCTIONS FOR CONTACTING A RANGER

If an emergency arises such as sickness or injury, or if you observe a violation or disturbance and wish to report it, contact the patrol ranger or any uniformed employee. If no one can be located, a public telephone is located next to the camptender's station at the entrance to the campground. Call 623-4466, 8:00 am - 4:30 pm daily, or after hours, call 623-4379, 623-4301, or 623-4348.

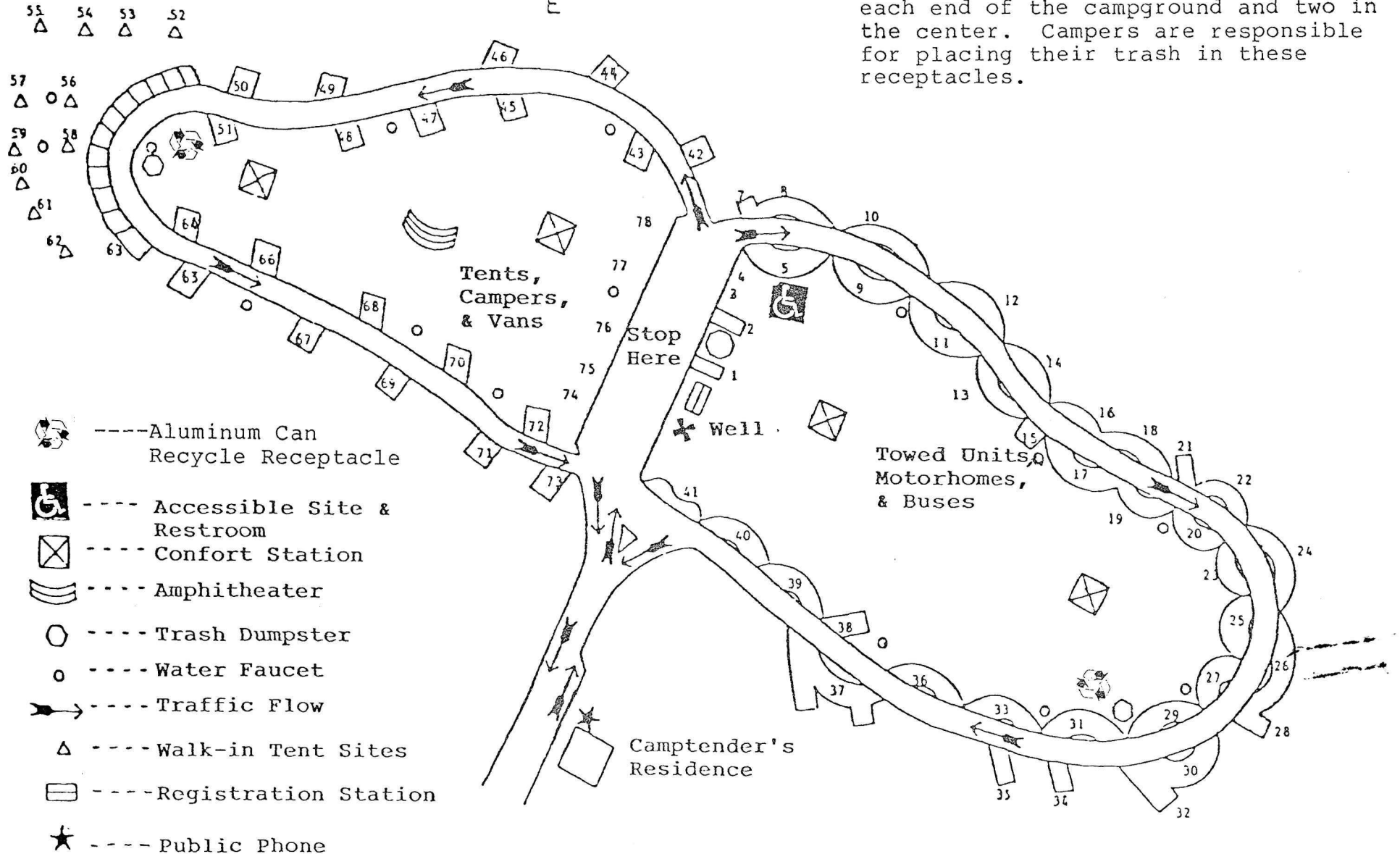
Do not hesitate to request assistance if you believe an emergency exists.

COLLECTION OF FIREWOOD IS PROHIBITED

Trash Dumpsters are located at key locations in the campgrounds: one at each end of the campground and two in the center. Campers are responsible for placing their trash in these receptacles.
