ENTRANCE AND USER FEES

By the authority of the Land and Water Conservation Act of 1965, 16 USC 4601-61 (as amended), the National Park Service and Theodore Roosevelt National Park are authorized to charge entrance and user fees at designated sites. Entrance fees are charged to all visitors except: those persons who have not reached their 16th birthday; those persons who have passed their 62nd birthday; those persons who have requested and been granted a waiver because of their participation in an organized tour or outing conducted for educational, therapeutic or scientific purposes not related to recreation. User fees (camping, special tours, etc.) are charged to all except the educational, therapeutic and scientific tours mentioned above. For persons who have passed their 62nd birthday and persons medically determined to be blind or permanently disabled, user fees are reduced 50 percent.

The current fees charge at Theodore Roosevelt National Park are as follows:

The short term entrance fees are good for seven days and allow entrance to either unit of the park during that period.

The single \$10.00 non-commercial annual park permit allows the holder and those accompanying him/her in a private vehicle to make as many visits to Theodore Roosevelt National Park during the year as they desire with no additional charges for entrance.

The Golden Eagle Passport, the Golden Age Passport, and the Golden Access Passport are available at the park during the fee collection season. The Golden Eagle Passport, priced at \$25.00, allows the holder and those accompanying him/her in a single private, non-commercial vehicle to enter federal recreation areas at no additional charge. The Golden Eagle Passport does not pay user fees. It is valid for the calendar year.

The Golden Age Passport is a lifetime pass issued to those persons 62 years of age and older. The passport is issued free upon proof of age and allows the holder and those accompanying him/her in a single private, non-commercial vehicle to enter federal recreation areas at no charge. It allows the holder free admittance when traveling on a commercial carrier.

The Golden Access Passport is also a free lifetime pass issued to persons who have been medically determined to be blind or permanently disabled and are eligible to receive benefits under federal law. The Golden Access Passport admits the holder and his or her accompanying spouse, children, and parents.

Both the Golden Age and the Golden Access Passports are issued only to citizens or permanent residents of the United States. Both passports provide for a 50% reduction of user fees but do not cover fees charged by private concessions.

Entrance fees are charged at Theodore Roosevelt National Park from May 1 through September 30. Camping fees, however, are charged from mid-April through October. Persons visiting the park before or after that time are not charged a fee since a full range of services is not being provided.
