### Hike the Hill


The American Hiking Society and the Partnership for the National Trails System cosponsored “Hike the Hill” gathering on February 8-13 in Washington, DC. Trail advocates from across the country attend to share information with and learn from their colleagues. Ursula Reed, Chair, W3R®-US, attended the sessions and represented the W3R®-US. While the private advocates gathered, federal trail administrators and managers also met to discuss interagency issues and provide updates. Joe DiBello attended the NPS National Trails staff meeting on February 10th and the U.S. Department of the Interior agency meeting in the afternoon. Joe also joined the NPS hike led by Don Briggs, Superintendent of Potomac Heritage National Scenic Trail, on a tour of a portion of the DC Fort Circle Trail. A retirement dinner for Steve Elkinton, who led the National Trails Program for NPS, was held the evening of February 12.

### Maryland Route Recons

Two components of the Phase 2 “Cultural Resource Survey of Land and Water Based Route Reconnaissance for the Washington-Rochambeau Revolutionary Route National Historic Trail in the State of Maryland” were recently completed by consulting historian Dr. Robert Selig. One report looked at Western Maryland and the Eastern Shore. The second study report looked at surviving resources within the Anacostia Trails Heritage Area of Prince George’s County. The studies were

coordinated by W3R®-MD President Robert Reyes and Ellen von Karajan of the Society for the Preservation of Federal Hill and Fell's Point, Inc. (The Preservation Society) as the key partner for the Maryland Chapter of the W3R®-US. Funding was provided through the Preservation Maryland Heritage Fund and Maryland Milestones, Anacostia Trails Heritage Area with matching support from the National Park Service through a Challenge Cost Share Program grant awarded to the W3R®-US.


## Unique Exhibit of Revolutionary War Illustrations



An exhibit of illustrations opened at the Valley Forge National Historic Park Visitor Center on February 22, 2014, which is Washington's Birthday. It will be there until April 28, and then it will be on display from June 23-August 26 at Morristown National Historic Park. *Bringing the War of Independence to Life: 19th Century Illustrations of the American Revolution* features a selection of 42 illustrations from Curt Zwickl's personal collection of 19th century Revolutionary War illustrations. Zwickl also penned a 24-page booklet as a companion piece to the exhibit. The beautifully illustrated booklet includes 20 images from the exhibit, and provides details about the artists who created the works. ## Registration of the Washington-Rochambeau NHT Logo

Amanda Jones of the NPS Northeast Regional Office is helping us advance the process of getting the Washington-Rochambeau NHT's official logo listed in the Federal Register. This will help us and our partners when using the logo on signs, publications, exhibits, etc. We have many requests pending for digital files for use by partners.

## Planning Ahead

Planning is critical to the future of the NHT, particularly in the ever-changing environment we face. Many of you have participated in the early phases of our strategic planning effort, and we have begun the next phase, which is what we call the Foundation Document. Building on the earlier efforts, this document will provide a base or foundation for future planning and action. Under the leadership of Allen Cooper, Chief of Planning, and Peter Iris-Williams, Planner, both with the NPS Northeast Regional Office, we are developing a draft purpose statement, significance statements, and themes. We hope to share some of the written material with you soon.

Phil Correll assembled our plan for the Northeast Region Servicewide Comprehensive Call which is a program that develops and refines our 5-year project funding forecast from 2016-2020. The project funding forecast is accompanied by a projected operating budget over the next five years. One of the immediate project needs is to update the Washington-Rochambeau NHT display now located in the Independence National Historical Park (INDE) Visitor Center at 6th and Market Streets in Philadelphia. We hope to refresh and enhance this display in cooperation with INDE and our partners.

The NPS is celebrating its centennial in 2016. The NPS' Call to Action plan offers tangible, concrete ways for us to work together to transform our organization to make sure that we are ready for a future that is so different from our past. ## Hurricane Sandy Disaster Relief Funding in Delaware

The Delaware Division of Historical and Cultural Affairs is now accepting disaster-relief funding applications for historic properties in the state that were damaged by Hurricane Sandy.

Hurricane Sandy Disaster Relief Assistance Grants for Historic Properties are funded under the Disaster Relief Appropriations Act, 2013, a \$50.7 billion package of disaster assistance largely focused on responding to the effects of the destructive hurricane which struck the East Coast of the United States in late October 2012. The hurricane prompted major disaster declarations in the District of Columbia and 12 states, including Delaware. As part of the act, Congress appropriated \$50 million to cover the costs of preserving and/or rehabilitating historic properties damaged by the storm. Subsequently, \$1 million was allocated for Delaware's component of the program which is being administered by the Division of Historical and Cultural Affairs' State Historic Preservation Office.

To be eligible for Hurricane Sandy Disaster Relief Assistance Grants for Historic Properties, a storm-damaged property must be: listed, or eligible for listing, in the National Register of Historic Places; owned by private individuals or organizations (excepting religious entities), local governments, or the state; and have documented damage that resulted from the effects of the storm. Repair work funded by the grants must also be consistent with the Secretary of the Interior's Standards for the Treatment of Historic Properties and in compliance with a number of other state and federal regulations. Already-completed projects may be eligible for funding if they meet applicable requirements. Applications must be postmarked or submitted no later than March 21, 2014. Successful applicants will receive notification of their awards no later than April 21, 2014.
