

OAK BOTTOM CAMPING

Upon arriving at Oak Bottom, all campers must follow the directional signs to obtain either tent or RV site registration instructions. Sites must be vacated by noon.

May 15 through September 15 - sites available through reservations

Reservations may be made no earlier than eight weeks in advance by calling 1-800-365-2267, or writing MISTIX Corporation, P.O. Box 85705, San Diego, CA 92138-5705. Specific sites may not be reserved in advance. Site assignments will be made upon arrival by campground staff.

September 16 through May 14 - sites available through self-registration

The Oak Bottom Campground is divided into two sections: A tent campground containing 100 walk-ins (no RV's) and a recreational vehicle (RV) campground, located in the large parking area near the launch ramp--which contains parking sites (no tents). Each tent site has a table, fire grate, and access to restrooms and water. Although all RV sites are near restrooms, none have tables or fire grates. Additional vehicles and all boat, utility and other trailers must be parked in the "designated overflow parking" near the RV area.

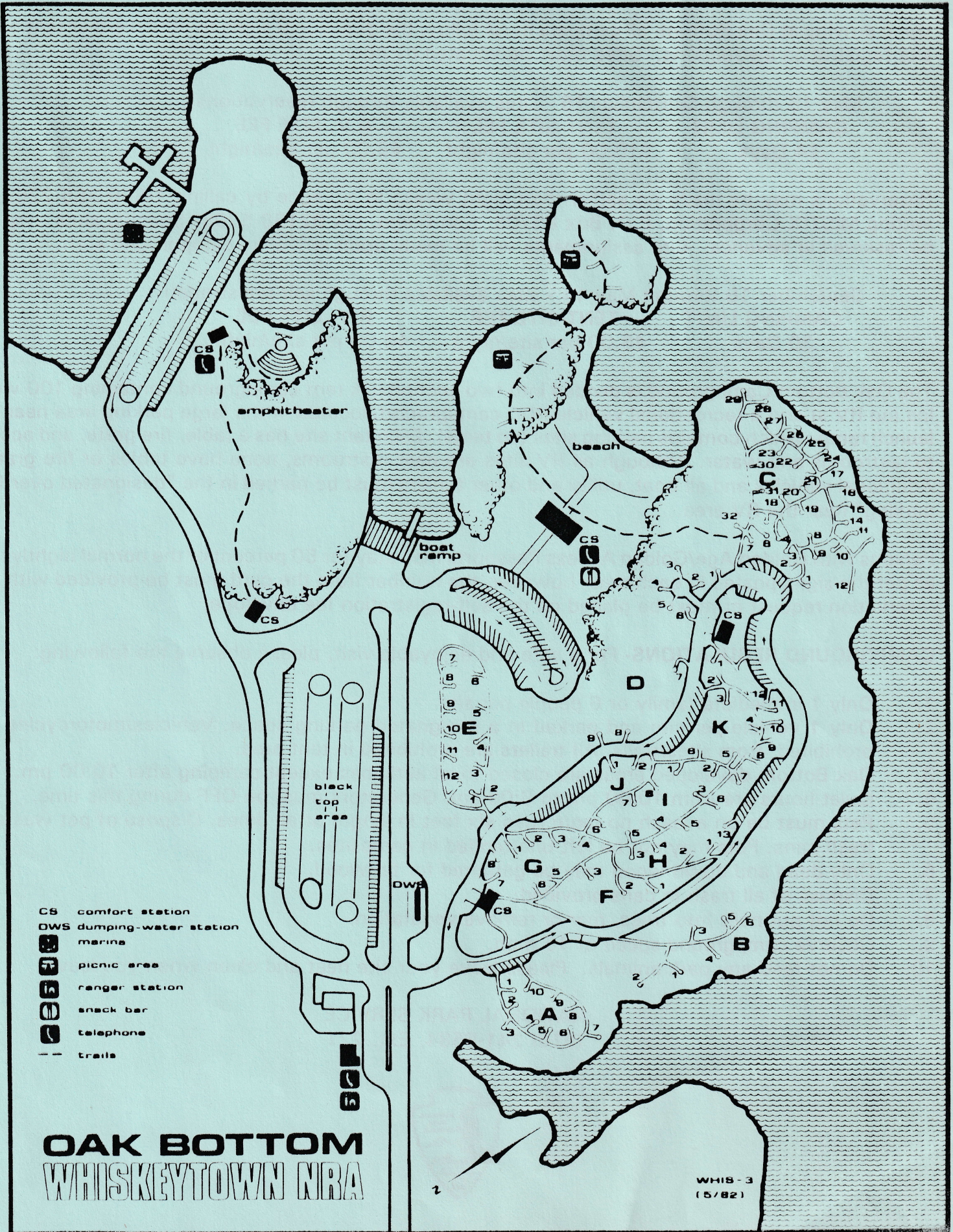
Persons with Golden Age/Golden Access Passports may stay for 50 percent of the normal nightly rate as per the signs posted in each area; however, the number from the card must be provided with the reservation request or must be placed on the self-registration fee envelope.

CAMPGROUND REGULATIONS- For a safe and enjoyable visit, please observe the following:

1. Only 1 immediate family or 6 people per site.
2. Only 1 vehicle per site and parked in a designated parking space. Vehicles/motorcycles are prohibited from sites/trails. **All trailers** are prohibited in tent area.
3. Oak Bottom developed areas are closed to all activities except camping after 10:00 pm.
4. Quiet hours are from 10:00 pm to 6:00 am. Generators must be OFF during this time.
5. Pets must be on a leash no more than six feet in length at all times. Dispose of pet waste in trash cans. Pets may not be left unattended in campsites.
6. Only dead and down wood may be gathered for firewood.
7. Dispose of all trash in cans provided.
8. Do not put nails into trees, mar or remove vegetation.
9. Observe campground speed of 15 mph.
10. Do not feed any park animals. Please leave your site neat and clean when you leave.
