### *"You Say Goodbye..."*

Three of our District Naturalists will be leaving us soon. **Matt Graves**, Grant District Naturalist, has accepted the position of East District Interpreter at Olympic National Park in Washington state. Matt has been at Grant since March 1994. He will be joined at Olympic by his wife Nancy, who has been working as a wildlife biologist for USFW in Portland, Oregon, for the past nine months. Previously, Nancy had worked at the Elk Refuge in Jackson but moved to Portland for a permanent job. Matt and Nancy are really looking forward to being together again! **Dan Hand**, Old Faithful District Naturalist, has accepted the Chief of Interpretation position at Coulee Dam National Recreation Area, also in the state of Washington. Dan joined our staff in October 1994, along with his wife Hughetta. They, too, were in a dual career situation. Hughetta worked a brief detail in Yellowstone's Fiscal Office last summer and was offered a permanent position as an Administration Technician at Buffalo National River in Arkansas in November. She will join Dan in Coulee as an Admin. Tech. at the Ft. Spokane District. **Roger Anderson**, Mammoth District Naturalist, is making a career change, leaving the NPS to join the private sector. He will be doing interpretation on a private consulting basis based in Bozeman.

### **Park Awarded \$15,000 by Foundation**

Yellowstone Park Superintendent Mike Finley was pleased to announce today that the park has received a \$15,000 grant from the National Park Foundation (NPF) to support the ongoing gray wolf restoration effort. The grant was made possible by a generous \$10,000 gift from NPF board member Homer Luther and his wife, Pat, and \$5,000 from the Foundation. The grant will help underwrite the wildlife veterinary services necessary for a safe restoration program in Yellowstone National Park.

"We're very happy to receive this generous grant from the Foundation. Having an experienced wildlife veterinarian who can administer the best possible care and husbandry is critical to the success of this restoration project," said Superintendent Finley. "Our experience in the first year of the project showed us how important it is to have veterinarian expertise working side-by-side with our biologists."

Wolf restoration began in Yellowstone National Park in January 1995, when 14 wolves from Alberta, Canada, were captured and transported to the park. They were held in acclimation pens and then released into the park in March 1995. Since their release, they have flourished. Two of the three groups had pups, and an estimated 4,000 visitors to the park observed the wolves performing their vital predatory role in the ecosystem. This year, 17 wolves were transported from British Columbia and currently remain in four acclimation pens in the park; they are tentatively scheduled to be released sometime in April.

"The National Park Foundation is pleased to be a partner to the Park in this historic effort," said NPF president Jim Maddy. "We're helping Yellowstone ensure that the howl of wolf will forever echo throughout the mountains and valleys of America's first National Park."

Founded by Congressional charter in 1967, the NPF is the official, nonprofit partner of the National Park Service (NPS). The Foundation raises private sector support to fund priority natural resource conservation, education and stewardship, and special NPF/NPS projects in the nation's 369 National Parks. In the past five years, NPF has awarded more than \$10.4 million in direct support to the Parks.

## Yellowstone Employee's Association Meeting Minutes

The Yellowstone Employees Association is a non-profit, employee organization that will sponsor social events to give employees from all divisions a chance to get to know each other and will benefit the federal employee by providing services such as offering support to employees by sending cards, flowers or money on occasions including weddings, childbirth, extended illness, or death of an employee or member of an employee's immediate family. An employee emergency loan fund will be set up. A membership card is being developed with hopes of using it to receive discounts from local businesses and park concessioners. Many ideas have been suggested, including holding Cookout Days, dances, picnics, etc., parkwide. We would like to sponsor a potluck lunch before each of the Superintendent's All Employee Meetings, with his approval. Membership in this organization will be voluntary. The initiation fee is \$2.00 and annual dues are \$1.00 per grade, with Seasonals paying 1/2 the regular rate.

Superintendent Finley has made the decision that parties with alcohol on government property and government time will no longer be allowed without a permit from the Y.E.A. due to liability concerns. The newly formed employee association will now buy insurance and permit parties thus releasing the government and its officers from all responsibilities and liabilities. Parties are defined as any gathering of employees with alcohol held in or on any government office, grounds, or community facility (excluding private functions held in employee housing) which are announced by use of government copy machines, fax machines, cc:Mail, and the Yellowstone News. This includes office Christmas parties, the Canyon Snowball, the Bechler Barn Dance, to name a few, as well as small get togethers to drink beer after meetings. Farewell parties serving alcohol will still be coordinated by each Division but will require a permit. This is a new way of doing business and may seem like a lot of red tape, but the permit process will be extremely easy, user friendly, and permits are free. A one page form must be filled out and can be obtained from any Y.E.A. officer. All announced parties will have wording to the effect of "sponsored by the Yellowstone Employees' Association," with exact wording, size and placing on the announcement to be worked out. The Superintendent has given his full support to this organization and will work with Y.E.A. to set up a long term funding source.

The Y.E.A. will do much more than just permit parties. Y.E.A. has some accomplishments already. On March 18, 1996, a St. Patrick's Day potluck lunch was held in the Canteen Gym. The gym was decorated and prizes were awarded for the best hats and derbies. As stated above, a membership card was selected from designs created by ADP. We have sent a condolence card with \$15 for a memorial fund to Dennis Zafft, whose mother recently passed away. Members of Y.E.A. will be manning the cookout grill at the March for Parks event in April. And we have selected Interim Officers to act on behalf of the Association


