YELLOWSTONE ROAD UPDATE

Construction from Madison Junction to Norris Junction:

September 3 - November 3

Weekdays: Open 6:00 p.m. to 10:00 p.m. and 6:00 a.m. to 10:00 a.m. with possible delays of up to 30 minutes.

Closed 10:00 a.m. to 6:00 p.m. and 10:00 p.m. to 6:00 a.m.

Weekends: Open 6:00 a.m. Saturday to 10:00 p.m. Sunday with possible delays of up to 30 minutes.

Fall Park Road Closures:

October 15

Dunraven Pass (Tower Fall to Canyon) closes.

November 4, 8:00 a.m.

All park roads close with the exception of the North Entrance to the Northeast Entrance, which remains open year-round to automobile traffic. This road is subject to temporary closures, and chains or snow tires may be required at times due to hazardous winter driving conditions.

Winter Season Road Openings:

Yellowstone is scheduled to open to oversnow vehicles on Wednesday, December 18 depending on sufficient snow and conditions.

Good health is a daily choice and as the seasons change, it's a perfect time to ensure yours by getting a blood profile. The Livingston Wellness Center will hold the fall health screen in the Gardiner School cafeteria on Wednesday, October 16 from 6:00 a.m. to 9:00 a.m. The costs for the tests are as follows:

Blood Profile Testing (diabetes, thyroid, kidney, liver, cholesterol screening and more)	\$35.00
Prostate Specific Antigen (Optional Blood Screening for Males)	\$18.00
ColoCare Kits	\$ 4.00

Political Activity (Hatch Act) and Time off for Voting

The following provides general guidance governing permitted and non-permitted political activities under the Hatch Act amendments, which establish provisions for all Federal employees. The general provisions for all federal employees are of primary concern during this election season and are repeated below.

Federal employees:

MAY	MAY NOT
Be candidates for public office in nonpartisan elections (where none of the candidates are running as representatives of a partisan political party)	Be candidates for public office in partisan elections (where candidates are identified by party)
Register and vote in any election	Use government funds to support political activity
Contribute money to political organizations and attend political fund raising functions	Be granted leave without pay to work on a political campaign
Attend and be active at political rallies and meetings	Use official title, authority, or influence to interfere with an election
Assist in voter registration drives	Solicit or receive political contributions (with limited specific exceptions)
Sign nominating petitions	Engage in political activity while on duty
Be paid for political work they do on their own time	Engage in political activity in any government office
Express personal opinions about candidates and issues	Wear political buttons while on duty or in government buildings
Campaign for or against referendum questions, constitutional amendments, municipal ordinance, etc.	Knowing solicit or discourage political activity of anyone with business before their agency
Distribute campaign literature in partisan elections	Display partisan political posters in their offices
Campaign for or against candidates in partisan elections	Engage in political activity while using a government vehicle
Make campaign speeches for candidates in partisan elections	Engage in political activity while wearing an official uniform
Hold office in political clubs or parties including serving as a delegate to a convention	Engage in political activity while using government property

All permitted political activities must be pursued on the Federal employee's own time. For more information, including questions and answers on political issues, check the Department of Interior's guidance on the Hatch Act at the following internet site: <http://www.doi.gov/ethics/political.html>.

Employees may not use government computers to vote in partisan elections at any time because government property cannot be used for political activity per 5 USC 7321-7326 and 5 CFR 733 and 734.

With the upcoming partisan elections, you may have questions concerning excused absences for the purpose of voting. Where polls are not open at least three (3) hours either before or after an employee's regular work hours, the employee may be granted an amount of excused leave which will permit the employee to report for work three (3) hours after the polls open or leave work 3 hours before the polls close, whichever requires the lesser amount of time. An employee's "regular work hours" are to be determined by reference to the time of day the employee normally arrives at and departs from work.

The current policies under the alternative work schedule and flexible workplace program allow employees many options in scheduling time to vote. Employees are able to schedule their work hours to allow sufficient time to vote, or they may also elect to vote by mail ballot. Under certain conditions, excused absence may be granted for voting registration and when the voting site is beyond normal commuting distance.

Employees should contact their supervisor if their work schedule does not allow them the time to have the opportunity to vote.

DISTINGUISHED SERVICE AWARD

This award is given each year to the author of the best article submission by a college student.
