 History of Structure: This inscription, possibly a fake by some later river runner, or left by French and Candian trapper Denis Julien on a trip down the Colorado River during the 1830s. Julien trapped the eastern Utah area during the late 1830s and early 1840s. Some sources say that the apparent "a" is actually mis-shaped script "e".

Evaluation of Structure: Historic Theme Contributing Non-Contributing _____
 National Register Criteria: B C D (Include integrity statement)
This inscription is fading rapidly and is barely legible. Equally, the inscription may be a fake as 3 field observers all agreed that the last name was mis-spelled "JULIAN."

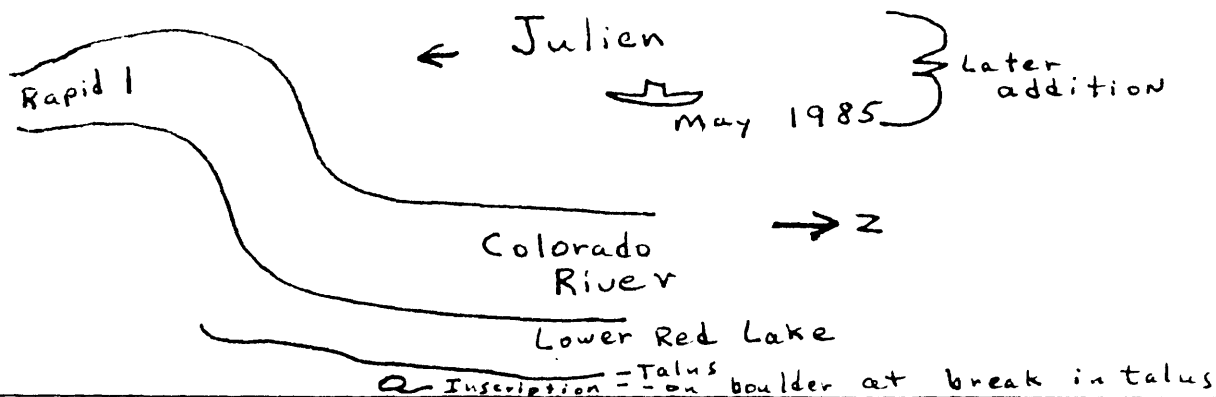

This resource exhibits no architectural features. It is accessible from the Colorado River or by overland hiking. The setting remains nearly as it was when Julien visited the site over 150 years ago and left his name and date. The inscription remains visible and shows no evidence that it was ever more extensive than it is today. However, examination of the site revealed that later visitors had also carved a message in the same boulder. It must be assumed that the Julien inscription looks as it did when placed there in 1836. The recent addition to the boulder does not diminish the integrity of the Julien inscription.
