## **Orderly Book – 1<sup>st</sup> NY Reg<sup>t</sup>, Major's Company (Ticonderoga has the Regimental Book)**

8 Sept 97 2:30 pm Frank Balduzzi transcriber –

Specs: 7 3/4" x 6 x 7/8"; 98 pages existing or 196 sides, originally more drab paper-covered cardboard covers, brown leather binding (mostly gone on spine) extending 1" onto covers which is then covered the cover sheet for 1/2". Only 3 1/4 - 3 1/2" of the front cover remains; full back cover. No writing on back or remaining front.

-- yellowish laid paper w/ ? \* watermark, linen thread horizontally \_\_\_ spine (5 rows) – thick string secured to groups of pages by finer thread; straight ... pin ... w/round metal head used to secure upper string which is mostly gone.

-- generally in bad shape rear covers but good in center section

\*only part of a mark appears on some pages, usually as a design but also the left TMW or WMT. The design is of a bird holding a branch in its beak.

Women & children; Native Americans; Punishment; Conditions; Officers on furlough; Fort construction; Exercise-Guard-Fatigue; major outside events; possible relationships between upper class, mostly Dutch office and the rank and file 50% foreign – born; prices for food & clothing, grammar, punctuation, diction, & writing styles; military ceremony, drum beats & daily schedule; days of week vs. activities.

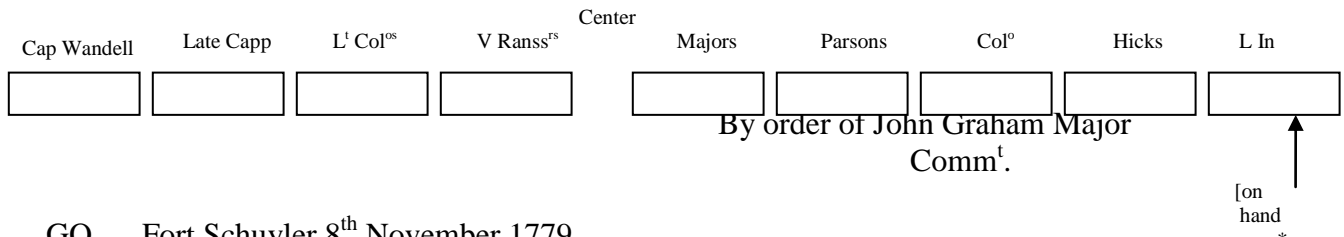

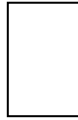
